3 **Ordinance authorizing settlement of the lawsuit filed by Terrance Heyward against the**  
4 **City and County of San Francisco for \$37,500; the lawsuit was filed on**  
5 **October 12, 2016, in San Francisco Superior Court, Case No. CGC-16-554799; entitled**  
6 **Terrance Heyward v. City and County of San Francisco, et al.; the lawsuit involves**  
7 **alleged personal injury on a City sidewalk.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Terrance Heyward v. City and County  
12 of San Francisco, et al., San Francisco Superior Court, Case No. CGC-16-554799 by the  
13 payment of \$37,500. The lawsuit involves alleged personal injury on a City sidewalk.

14 Section 2. The above-named action was filed in San Francisco Superior Court on  
15 October 12, 2016, and the following parties were named in the lawsuit: plaintiff: Terrance  
16 Heyward; defendants: City and County of San Francisco and Pref 580 Market, LLC.




