[Settlement of Lawsuit - Cui Ying Zhou, Jian Cong Tan, Angelina Tan, and Arosia Tan - \$14,500,000]

Ordinance authorizing settlement of the lawsuit filed by Cui Ying Zhou, Jian Cong Tan, Angelina Tan, and Arosia Tan against the City and County of San Francisco for \$14,500,000; the lawsuit was filed on November 26, 2016, in San Francisco Superior Court, Case No. CGC-16-555523; entitled Cui Ying Zhou, et al. v. City and County of San Francisco, et al.; the lawsuit involves an alleged personal injury in Washington Square Park.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>Cui Ying Zhou</u>, et al. v. City and County of San <u>Francisco</u>, et al., San Francisco Superior Court, Case No. CGC-16-555523 by the payment of \$14,500,000. The lawsuit involves an alleged personal injury in Washington Square Park.

Section 2. The above-named action was filed in San Francisco Superior Court on November 26, 2016, and the following parties were named in the lawsuit: Cui Ying Zhou, Jian Cong Tan, Angelina Tan, and Arosia Tan, Plaintiffs; City and County of San Francisco and Hortscience, Inc., Defendants.
