[Accept and Expend Grant - San Francisco Parks Alliance - Scholarship Programs - \$150,000]

Resolution authorizing the Recreation and Park Department to accept and expend a grant of \$150,000 from the San Francisco Parks Alliance to benefit the Department's scholarship program for the project term of November 1, 2018, through June 30, 2019.

WHEREAS, The City, through the Recreation and Park Department ("RPD"), operates the Edwin M. Lee scholarship program which helps to subsidize the cost of attending RPD recreation programs for eligible residents, ensuring that all San Franciscans can access RPD programs regardless of ability or inability to pay; and

WHEREAS, Since 1971 the San Francisco Parks Alliance ("SFPA"), a non-profit organization, has been a partner of, fiscal sponsor to and philanthropic benefactor of the Recreation and Park Department, supporting San Francisco's parks, open spaces and recreation programs; and

WHEREAS, RPD, in partnership with SFPA as fiscal sponsor, holds an annual fundraiser event each February known as Crab Fest, which provides important support each year for the scholarship program; and

WHEREAS, SFPA wishes to grant RPD a cash grant of \$150,000, generated from this year's Crab Fest event, to benefit the scholarship program; and

WHEREAS, On June 21, 2018, the Recreation and Park Commission, by Resolution No. 1806-004, recommended that the Board of Supervisors authorize RPD to accept and expend a cash grant in the amount of \$150,000 from SFPA to support the Edwin M. Lee scholarship program; now, therefore, be it
