16 Be it ordained by the People of the City and County of San Francisco:

17 Section 1. Findings.

18 (a) The Planning Department has determined that the actions contemplated in this
19 ordinance comply with the California Environmental Quality Act (California Public Resources
20 Code Sections 21000 et seq.). Said determination is on file with the Clerk of the Board of
21 Supervisors in File No. 180053 and is incorporated herein by reference. The Board affirms
22 this determination.

23 (b) On March 15, 2018, the Planning Commission, in Resolution No. 20135, adopted
24 findings that the actions contemplated in this ordinance are consistent, on balance, with the
25 City's General Plan and eight priority policies of Planning Code Section 101.1. The Board

1 adopts these findings as its own. A copy of said Resolution is on file with the Clerk of the
2 Board of Supervisors in File No. 180053, and is incorporated herein by reference.

3 (c) Pursuant to Planning Code Section 302, this Board finds that this Planning Code
4 Amendment will serve the public necessity, convenience, and welfare for the reasons set forth
5 in Planning Commission Resolution No. 20135, and the Board incorporates such reasons
6 herein by reference.

8 Section 2. The Planning Code is hereby amended by revising Section 725, to read as
9 follows:

10 SEC. 725. UNION STREET NEIGHBORHOOD COMMERCIAL DISTRICT.

19 Any Message Establishment that has continually operated without the benefit of a
20 building permit within the Union Street NCD since prior to December 31, 2017 shall not
21 require a Conditional Use authorization to legally establish the Message Establishment.
22 However, such establishments must file a building permit application by May 1, 2020 to legally
23 establish the Message Establishment use, and such building permit application will be subject
24 to neighborhood notification pursuant to Planning Code Section 311.

Section 3. Effective Date. This ordinance shall become effective 30 days after enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board of Supervisors overrides the Mayor's veto of the ordinance.

Section 4. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors intends to amend only those words, phrases, paragraphs, subsections, sections, articles, numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal Code that are explicitly shown in this ordinance as additions, deletions, Board amendment additions, and Board amendment deletions in accordance with the "Note" that appears under the official title of the ordinance.




