16 Section 1. Article III of the Campaign and Governmental Conduct Code is hereby
17 amended by revising Sections 3.1-120, 3.1-140, 3.1-145, 3.1-150, 3.1-165, 3.1-175, 3.1-195,
18 3.1-218, 3.1-225, 3.1-230, 3.1-251, 3.1-252, 3.1-273, 3.1-275, 3.1-295, 3.1-315, 3.1-320, 3.1-
19 335, 3.1-340, 3.1-422, 3.1-345, 3.1-365, 3.1-390, 3.1-420, 3.1-450, and 3.1-500, to read as
20 follows:

21 **SEC. 3.1-120. AIRPORT.**

22 (a) **Disclosure Category 2.** Persons in this category shall disclose all investments
23 and business positions in business entities and income from any source which provides, or
24 contracts with the City and County of San Francisco and its Airport Commission to provide,
25 services, supplies, materials, machinery, or equipment to the Airport Commission.

(b) **Disclosure Category 3.** Persons in this category shall disclose all investments and business positions in business entities, interests in real property, and income from any source subject to the regulatory, permitting, or licensing authority of the Airport Commission.

SEC. 3.1-500. POSITIONS FOR WHICH THE FAIR POLITICAL PRACTICES COMMISSION IS THE FILING OFFICER.

Members of the Board of Supervisors, District Attorney, Mayor, City Administrator, City Attorney, Treasurer, and members of the Planning Commission shall *electronically* file one original of all statements of economic interests with the Ethics Commission, the filing official, who shall ~~make and retain a copy and forward the original~~ *electronically transmit a scanned copy* to the Fair Political Practices Commission which shall be the filing officer.

Section 2. Effective Date. This ordinance shall become effective 30 days after enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board of Supervisors overrides the Mayor’s veto of the ordinance.

Section 3. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors intends to amend only those words, phrases, paragraphs, subsections, sections, articles, numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal Code that are explicitly shown in this ordinance as additions, deletions, Board amendment additions, and Board amendment deletions in accordance with the “Note” that appears under the official title of the ordinance.
