3 Ordinance amending the Administrative Code to modify the daily use fees to engage in  
4 film production, to extend the Film Rebate Program through 2028, to correspondingly  
5 increase the authorized funding cap for the Film Rebate Project Account from  
6 \$4,000,000 to \$4413,000,000; and to add administrative penalties for violations of  
7 requirements of Film Commission programs.

15 Be it ordained by the People of the City and County of San Francisco:

16 Section 1. The Administrative Code is hereby amended by revising Section 57.1, to  
17 read as follows:

18 **SEC. 57.1. DEFINITIONS.**

19 *For purposes of this Chapter 57, the following terms shall have the following meanings:*

20 (a) "City" means the City and County of San Francisco.

21 (b) "Commission" means the Film Commission of the City and County of San  
22 Francisco.

23 (c) "Film" means feature motion pictures, video tapes, television programs,  
24 commercials, still photography, documentaries, travelogues, music videos, web videos, web  
25 series, and other visual art forms; provided however, that "film" shall not mean films or video

1 tapes for private-family use or films by any news service or similar entity engaged in on-the-  
2 spot print media, publishing, or broadcasting, of news events.

3 (d) "Film company" means any individual, corporation, firm, partnership, or other  
4 organization however organized engaged in film production.

5 (e) "Film production" means the activity of making a film for commercial or  
6 noncommercial property where that activity (1) requires the use of City employees or  
7 equipment or (2) interferes with the ordinary use, safety, and enjoyment of public right-of-ways  
8 or other property under the jurisdiction of the City.

9 "Season" means the initial exhibition of a set of interrelated new episodes within a 12-month  
10 period.

11  
12 Section 2. The Administrative Code is hereby amended by revising Section 57.5, to  
13 read as follows:

14 **SEC. 57.5. AUTHORIZATION TO ENTER INTO USE CONTRACTS AND**  
15 **COORDINATE CITY DEPARTMENTS REGARDING FILM COMPANIES; CONSENT OF**  
16 **RELEVANT DEPARTMENTS; COST RECOVERY; SIDEWALK CLOSURE AND POSTING.**

17 (a) Use Contracts; Deposit of Funds. The Executive Director may enter into use  
18 contracts with organizations seeking to engage in film production. The Executive Director shall  
19 be the sole City representative authorized to negotiate use contracts. Such contracts shall, at  
20 a minimum, provide for the full recovery of costs incurred by the various City departments in  
21 providing the use of City employees, equipment, and rental facilities or rental properties.  
22 Funds to reimburse City departments for costs incurred by those departments for the  
23 deployment of personnel or equipment or use of rental facilities or rental properties shall be  
24 paid directly to those departments for deposit subject to the budget and fiscal provisions of the  
25 Charter.

1           \* \* \* \*

2           (c) **Schedule of Costs.** In addition to the reimbursement of City departments for the  
3 costs incurred by those departments in deploying personnel or equipment, the Film  
4 Commission may, consistent with Charter Section 2.109, charge daily use fees to film  
5 companies seeking to engage in film production. The use fees are as follows:

6           (1) Still photography: \$100 a day.

7           (2) A commercial, corporate media, industrial media, videos, *short subject*, or web  
8 video: \$200 a day.

9           (3) A television series (*each episode*), web series (*each episode*), movie, pilot, *short*  
10 *subject*, or documentary:

11           (A) For a production with a budget of less than \$100,000: \$50 a day.

12           (B) For a production with a budget of \$100,000 to less than \$500,000: \$100 a  
13 day.

14           (C) For a production with a budget of \$500,000 or greater: \$300 a day.

15           Public service announcements, qualifying student productions, and productions created  
16 by *or for* entities that are tax-exempt under section 501(c)(3) of the Internal Revenue Code  
17 are exempt from the above-listed use fees. The revenue generated by such use fees shall be  
18 deposited in the San Francisco Film Production Fund.

19           (d) **Sidewalk Closures and Sign-Posting.** The Film Commission may require that  
20 film companies use City personnel or City-approved vendors to post notice of the closure of  
21 City streets and sidewalks for film production, and may establish minimum sign-posting  
22 requirements. Notwithstanding anything to the contrary in Section 724 of the Public Works  
23 Code, the Executive Director may authorize the temporary occupancy of public sidewalks for  
24 film production, with the consent of the Department of Public Works, subject to all  
25 requirements and conditions of the Department of Public Works and *Department of Parking and*

1 ~~Traffic~~ the San Francisco Municipal Transportation Agency. Street closures for film production  
2 shall be governed by applicable provisions of the Transportation Code.

3  
4 Section 3. The Administrative Code is hereby amended by revising Section 57.8, to  
5 read as follows:

6 **SEC. 57.8. FILM REBATE PROGRAM.**

7 \* \* \* \*

8 (c) **Rebate Program.**

9 (1) **Allowance of Rebate.** A qualified low-budget film production or qualified film  
10 production that pays qualified production costs shall be entitled to a rebate, to be calculated  
11 as provided herein, provided that the qualified production has entered into a first source hiring  
12 agreement with the City that demonstrates good faith efforts to hire economically  
13 disadvantaged individuals referred by the San Francisco Workforce Development System to  
14 work for the qualified production. Good faith efforts shall include, at a minimum, consulting  
15 with the First Source Hiring Administration ("FSHA") for the purpose of preparing a list of  
16 positions for which individuals referred by the City might qualify, providing that list to the FSHA  
17 at least two weeks prior to the first day of shooting, and documenting efforts to contact and  
18 interview job candidates referred by the City to fill the positions listed.

19 (2) **Amount of Rebate.** ~~Effective Starting~~ July 1, 2015, the City shall pay one dollar  
20 for each dollar the qualified low budget film production or qualified film production paid in  
21 qualified production costs not to exceed ~~\$44~~13,000,000 by ~~July 1, 2019~~June 30, 2028, provided  
22 that such rebate payment shall not exceed \$600,000 for each such production. No television  
23 series or web series shall qualify for more than \$600,000 in rebate payments per season. The rebates  
24 shall be paid from the project account that the Controller has set aside for Film Rebate  
25 Program funds (the "Film Rebate Project Account"). The rebates shall not be paid from funds

1 dedicated under bond or other legal financing covenants. Rebates paid under this Section  
2 57.8 shall be paid only to those qualified low budget film productions or qualified film  
3 productions whose filming commenced on or after May 20, 2006.

4 (3) **Implementation.** After holding a public hearing, the Executive Director of the  
5 Film Commission, in consultation with the Controller, shall promulgate rules and regulations to  
6 establish the procedures for implementation of the Film Rebate Program. Such rules shall  
7 include provisions describing the application process, the standards used to evaluate the  
8 applications, the documentation that will be required to substantiate the amount of the rebate,  
9 the appeal process, and any such other provisions as deemed necessary and appropriate to  
10 carry out the Film Rebate Program.

11 \* \* \* \*

12 (f) Expiration of Section. The Film Rebate Program shall expire on June 30, ~~2019~~  
13 2028, unless extended by ordinance. If the Film Rebate Program is not extended, the City  
14 Attorney shall cause this Section to be removed from the Administrative Code.

15  
16 Section 4. The Administrative Code is hereby amended by adding Section 57.9, to  
17 read as follows:

18 **SEC. 57.9. ADMINISTRATIVE PENALTIES.**

19 (a) The Executive Director or his or her designee may issue a citation imposing an  
20 administrative penalty in an amount of up to three times the applicable use fee under Section 57.5(c) of  
21 this Chapter 57 to any person that has violated this Chapter. The amount of such administrative penalty  
22 will be based on the impact of the violation on the community, the impact of the violation on the City,  
23 the amount of staff time needed to investigate and address such violations, and such other factors as  
24 justice may require.

1           **(b) Except as provided in subsection (a), setting forth the amount of administrative fines,**  
2           **Administrative Code Chapter 100, "Procedures Governing the Imposition of Administrative Fines," as**  
3           **may be amended from time to time, is hereby incorporated in its entirety and shall govern the**  
4           **procedure for imposition, enforcement, collection, and administrative review of administrative citations**  
5           **issued by the Executive Director or his or her designee to enforce this Chapter 57.**

6           **(c) If a film company did not enter into a use contract to engage in film production and is**  
7           **seeking a certification that the film was made in compliance with the laws of the jurisdiction where it**  
8           **was filmed, the film company will receive a certification of compliance upon payment of the**  
9           **administrative penalty, evidence of insurance as required by the City Risk Manager, if such insurance**  
10           **was in effect at the time of filming, and upon signing an agreement to hold the City harmless for any**  
11           **costs associated with any loss or claim attributable to any of the activities of the film production in**  
12           **connection with the filming.**


13           **(d) The Executive Director may require a film company seeking to engage in film production to**  
14           **pay any unpaid administrative fines imposed under this Section 57.9 prior to entering into any further**  
15           **use contracts.**

16  
17           Section 5. Effective Date. This ordinance shall become effective 30 days after  
18           enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the  
19           ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board  
20           of Supervisors overrides the Mayor's veto of the ordinance.

21  
22           Section 6. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors  
23           intends to amend only those words, phrases, paragraphs, subsections, sections, articles,  
24           numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal  
25           Code that are explicitly shown in this ordinance as additions, deletions, Board amendment

1 additions, and Board amendment deletions in accordance with the "Note" that appears under  
2 the official title of the ordinance.

**LEGISLATIVE DIGEST**

[Administrative Code - Film Commission Programs]

**Ordinance amending the Administrative Code to modify the daily use fees to engage in film production, to extend the Film Rebate Program through 2028, to correspondingly increase the authorized funding cap for the Film Rebate Project Account from \$4,000,000 to \$13,000,000; and to add administrative penalties for violations of requirements of Film Commission programs.**

Existing Law

Existing law provides for the Film Rebate Program. The purpose of the Film Rebate Program is to increase the number of qualified film productions being made in San Francisco, increase the number of City residents employed in the filmmaking industry, and encourage the resulting economic benefits from increased filmmaking in San Francisco. Under the Film Rebate Program, the City pays one dollar for each dollar a “qualified low budget film production” or “qualified film production” pays in certain production costs to the City, not to exceed the \$4,000,000 cap on the Film Rebate Project Account.

The Film Rebate Program is scheduled to sunset on June 30, 2019.

Administrative Code Chapter 57, which establishes the City’s Film Commission, does not provide for any penalties if a film production violates the requirements of Film Commission programs.

Amendments to Current Law

The proposed ordinance provides that the sunset date for the Film Rebate Program is extended to June 30, 2028, and the cap on the Film Rebate Project Account is increased to \$13,000,000.

The proposed ordinance also provides for administrative penalties in an amount up to three times the applicable use fee to any person who has violated the requirements of Film Commission programs. A film production seeking certification that a film was made in compliance with the laws of the jurisdiction where it was filmed, but that did not enter into a use contract at the time of filming, could receive a certification of compliance upon payment of the administrative penalty and upon signing an agreement to hold the City harmless for any costs associated with any loss or claim attributable to any of the activities of the film production in connection with the filming.

**EXECUTIVE SUMMARY**

**Legislative Objectives**

- The proposed ordinance would amend the Administrative Code to modify (a) daily use fees to engage in film production, (b) extend the Film Rebate Program from July 1, 2015 through June 30, 2028, for a total of 13 years, (c) increase the authorized funding cap for the Film Rebate Project Account from \$4,000,000 to \$14,000,000, and (d) add administrative penalties for violations of requirements of the Film Commission Programs.

**Key Points**

- In 2006, the Board of Supervisors approved the Film Rebate Program, which allows film production companies, who produce qualified film productions, to receive a rebate of up to 100 percent of qualifying costs previously paid to the City.
- In 2015, the Board of Supervisors approved amending the ordinance to extend the Film Rebate Program from July 1, 2015 through June 30, 2019, and establish a funding cap of \$4,000,000 over the four year period for the total amount of rebates to be paid by the City to qualified film production companies.

**Fiscal Impact**

- The Film Rebate Program has paid \$5,522,876 in rebates between FY 2006-07 and FY 2017-18. To date, 27 films and TV shows have used the film rebate program.
- The total Film Rebate Program appropriations between FY 2015-16 and FY 2017-18 were \$2,400,000 and total rebates were \$1,827,014, for total funds carried forward from FY 2017-18 of \$577,124. The Board of Supervisors appropriated \$800,000 to the Film Rebate Program in FY 2018-19, for total available funds of \$1,377,124.
- The proposed ordinance would increase the authorized funding cap for the Film Rebate Program by \$10,000,000 from \$4,000,000 to \$14,000,000, and extend the program by nine years through June 30, 2028. However, according to the Film Commission, the Film Rebate Program needs funding of \$1,000,000 per year, totaling \$9,000,000 for the nine-year period from July 1, 2019 through June 30, 2028. Therefore, the funding cap should be \$13,000,000 (or \$9,000,000 more than the current cap of \$4,000,000) rather than \$14,000,000, as stated in the proposed ordinance. The proposed ordinance should be amended to reduce the funding cap from \$14,000,000 to \$13,000,000.
- The proposed ordinance does not set a minimum or maximum amount that the Board of Supervisors would be required to appropriate to the Film Rebate Program each year.

**Recommendations**

- Amend the ordinance to reduce the funding cap from \$14,000,000 to \$13,000,000.
- Approval is a policy matter for the Board of Supervisors.

**MANDATE STATEMENT**

According to City Charter Section 2.105, the Board of Supervisors shall only act by written ordinance or resolution, except that it may act by motion on matters over which the Board of Supervisors has exclusive jurisdiction.

**BACKGROUND**

In April of 2006, the Board of Supervisors approved the Film Rebate Program (File 06-0065), which allows film production companies, who produce qualified film productions or qualified low-budget film productions, to receive a rebate of up to 100 percent of qualifying costs previously paid to the City. Qualifying costs include:

- Taxes paid to the City, not including hotel or sales tax;
- City departments' costs for the use of the departments' equipment, property or employees' time;
- Film Commission's daily use permit fees;
- Police officers' time, up to four police officers per day for a maximum of 12 hours per day per police officer; and
- Property lease costs, when alternative City property is not available.

Administrative Code Section 57.8 states that the purpose of the Film Rebate Program is to increase the (a) number of film productions in San Francisco, (b) number of City residents employed in the filmmaking industry, and (c) resulting economic benefits to San Francisco. Administrative Code Section 57.8(c)(2) initially specified that the total amount of rebates paid by the City to the film production companies shall not exceed \$1,800,000 through June 30, 2009.

In 2009, the Board of Supervisors approved a two-year extension to the Film Rebate Program, through June 2012 (File 09-0627).

In 2012, the Board of Supervisors approved extending the Film Rebate Program for two additional years, through June 30, 2014, and increasing the total amount of available funds up to \$2,000,000 for film rebates during that period (File 12-0406).

In 2013, the Board of Supervisors approved extending the Film Rebate Program for one additional year, through June 30, 2015, and increasing the total amount of available funds up to \$3,000,000 (File 13-0937).

In April 2015, the Board of Supervisors approved amending the ordinance to extend the Film Rebate Program from July 1, 2015 through June 30, 2019, and establish a funding limit of \$4,000,000 over the four year period for the total amount of rebates to be paid by the City to qualified film production companies, subject to appropriation approval by the Board of Supervisors (File 15-0463). In addition, the Administrative Code provides that film production companies must demonstrate good faith efforts to hire San Francisco residents through the City's First Source hiring program.

Qualified film productions include any feature length film, documentary, docudrama, television film, television pilot, reality program or each episode of a television series or web series where 65 percent of the days are filmed in the City. Qualified low-budget film productions include any feature length film, documentary, docudrama, television film, television pilot, reality program or each episode of a television series or web series where at least 55 percent of the days are filmed in the City and the total budget is \$3,000,000 or less.

To date, 27 films and TV shows have used the film rebate program.

## **DETAILS OF PROPOSED LEGISLATION**

The proposed ordinance would amend the Administrative Code to modify (a) daily use fees to engage in film production, (b) extend the Film Rebate Program from July 1, 2015 through June 30, 2028 for a total of 13 years, (c) increase the authorized funding cap for the Film Rebate Project Account from \$4,000,000 to \$14,000,000, and (d) add administrative penalties for violations of requirements of the Film Commission Programs.

### **Daily Use Fees**

The proposed ordinance would allow low-budget short films to qualify for the low budget production daily use fee. Currently, short films must pay \$200 per day for filming, which, according to Ms. Susannah Robbins, Executive Director of the San Francisco Films Commission, is prohibitively expensive for small budget short films. The proposed changes to the ordinance would allow short films to qualify for daily permit fees of between \$50 and \$100.<sup>1</sup>

The proposed ordinance would also allow exemptions of fees for productions created by or for entities that are tax exempt under section 501(c)(3) of the Internal Revenue Code.

### **Extension through 2028**

The current program's sunset date is June 30, 2019. The proposed ordinance would extend the program by an additional nine years to June 30, 2028. In the past, the program has been extended by smaller increments. According to Ms. Robbins, many productions begin to budget two years prior to filming. The longer extension will give producers more confidence that the rebate program will remain for projects that extend over many years.

### **Administrative Penalties**

The proposed ordinance establishes administrative penalties of up to three times the applicable user fee for any person in violation of Chapter 57, which details the Film Rebate Program. The amount of the administrative penalty will be based on the impact of the violation on the community, the amount of staff time needed to investigate and address such violations, and such other factors as justice may require. In addition, a film production seeking certification that a film was made in compliance with the laws of the jurisdiction where it was filmed, but that did not enter into a use contract at the time of filming, could receive a certification of

compliance upon payment of the administrative penalty. There are currently no administrative penalties.

## FISCAL IMPACT

The Film Rebate Program has paid \$5,522,876 in rebates between FY 2006-07 and FY 2017-18, as shown in Table 1 below.

As shown in Table 1 above, annual expenditures ranged from \$0 to \$1,097,654 per year. All unspent funds are carried forward to the new fiscal year. The Film Rebate Program currently has a fund balance of \$577,124 from FY 2017-18.

### Annual appropriation to the Film Rebate Program

The Film Rebate Program funds are General Fund monies subject to Board of Supervisors approval. The Board of Supervisors allocated \$1.8 million to the program in 2006 and \$2 million to the program in 2012. In 2014, the Board of Supervisors extended Film Rebate Program for four years from FY 2015-16 to FY 2018-19. The Board of Supervisors set the program not-to-exceed amount at \$4 million over the four-year period, and has appropriated \$3,200,000 through FY 2018-19.

The total Film Rebate Program appropriations between FY 2015-16 and FY 2017-18 were \$2,400,000 and total rebates were \$1,827,014, for total funds carried forward from FY 2017-18 of \$577,124. The Board of Supervisors appropriated \$800,000 to the Film Rebate Program in FY 2018-19, for total available funds of \$1,377,124.

### Proposed Reduction in Funding Cap

The proposed ordinance would increase the authorized funding cap for the Film Rebate Program by \$10,000,000 from \$4,000,000 to \$14,000,000, and extend the program by nine years through June 30, 2028. However, according to Ms. Robbins, the Film Commission needs Film Rebate Program funding of \$1,000,000 per year, totaling \$9,000,000 for the nine-year period from July 1, 2019 through June 30, 2028. Therefore, the funding cap should be \$13,000,000 (or \$9,000,000 more than the current cap of \$4,000,000) rather than \$14,000,000, as stated in the proposed ordinance. The proposed ordinance should be amended to reduce the funding cap from \$14,000,000 to \$13,000,000.

The proposed ordinance does not set a minimum or maximum amount that the Board of Supervisors would be required to appropriate to the Film Rebate Program each year.

### POLICY CONSIDERATION

**The Film Commission estimates that the Program has generated \$28,908,205 in spending in San Francisco since June 2013**

Based on data pertaining to the film rebate program provided by the Film Commission, Table 2 below shows the estimated direct spending in the San Francisco economy generated by film productions for which rebates were paid in the past five completed fiscal years. As shown below, every dollar the City expended on film rebates between FY 2013-14 and FY 2017-18 generated between \$3.58 and \$11.69 in direct spending in San Francisco. This assumes that these productions would not film in San Francisco were it not for the Film Rebate Program.

The legislation previously approved by the Board of Supervisors authorizing the Film Rebate Program requires that the Director of the Film Commission provide the Board of Supervisors with an annual report on the implementation of the film rebate program. The Budget and Legislative Analyst has confirmed that these reports were submitted to the Board of

Supervisors for all fiscal years except FY 2015-16.<sup>2</sup> According to Ms. Robbins, the Film Commission plans to submit the annual report for FY 2017-18 by December 31<sup>st</sup>.

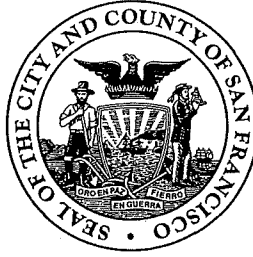
## RECOMMENDATIONS


