Be it ordained by the People of the City and County of San Francisco: Section 1. Findings.

(a) In Resolution No. 299-15, the City and County of San Francisco (the "City") established a property-based business improvement district called the Greater Rincon Hill Community Benefit District (also known as the East Cut Community Benefit District) (the "District"). On December 29, 2015, the City and the Greater Rincon Hill Association, a nonprofit corporation acting as the owners' association of the District, entered into an agreement for the administration of the District, establishing certain responsibilities and requirements for the implementation, administration, and provision of the property-related services, improvements, and activities, to be funded by the assessments within the District. Among other responsibilities, the District uses assessment funds to provide street tree maintenance to supplement City services in the District.

(b) Public Works Code Section 724.1 requires that anyone who receives a permit for temporary street space occupancy for building construction operations or other purposes pay an associated fee to the City. The Greater Rincon Hill Association anticipates that it will need to obtain temporary street space occupancy permits in connection with its planned street tree pruning and maintenance activities in 2018 and 2019. To minimize the financial impact on the District from payment of these fees, this ordinance waives the application of the temporary street space occupancy fees in connection with these activities.

Section 2. Fee Waiver. The temporary street occupancy permit fee required under Public Works Code Section 724.1 shall not apply to permits obtained by the Greater Rincon Hill Association to facilitate the maintenance, removal, or planting of street trees within the District between September 1, 2018, and June 30, 2019.

Section 3. Effective Date; Retroactivity. This ordinance shall become effective 30 days after enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board of Supervisors overrides the Mayor's veto of the ordinance. The ordinance shall be retroactive to September 1, 2018.
