








SF Auto Burglary Hot Spots 2018



Comprehensive Plan

Goal

To develop strategies at the district station level that will reduce overall property crimes (burglary, larceny-theft, and motor vehicle theft) with an emphasis on automobile break-ins, bicycle theft, and residential/commercial burglaries through the assignment of a station Property Crime Liaison.

Strategies

- Designate a Property Crime Liaison Officer at each district station
- Work alongside the centralized General Crimes Unit
- Network with Neighborhood District Attorney
- Focus on prolific offenders
- Create data metrics that ensure transparency and accountability

Comprehensive Plan

Property Crime Liaison

Each Station: Point of contact for community; Coordinate proactive and crime deterrent strategies; Track and assign property crime cases for investigation; Coordinate with the Neighborhood District Attorney for prosecution; Organize deployment of additional department resources as needed; Coordinate community outreach

Three tiered approach

1. Enforcement 2. Education 3. Environment

Pilot Station Activities

- Increase foot beat officers
- Educate merchant and neighborhood associations
- Target areas including retail parking garages
- Bait car and bike operations
- Surveillance team deployment



Mission Station Pilot

Most effective:

- Flexibility and adaptability with strategy are key.
- Listen to community and business owners.
- Taking feedback and advice from individuals in the community.

Least effective:

• Keeping one set strategy.

Taraval Station Pilot

Most effective:

- Meeting with merchants and residents, and educating visitors, handing out Park Smart flyers.
- Directed patrols based on prior incidents.

Least effective:

• Conducting plain clothes operations to observe crimes in progress.


