9 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
10 authorizes the City Attorney to settle the action entitled Lucille Sullivan v. City and County of
11 San Francisco, San Francisco Superior Court, Case No. CGC-17-559902 by the payment
12 of \$40,000. The lawsuit involves a trip and fall.

13 Section 2. The above-named action was filed in San Francisco Superior Court on
14 July 3, 2017, and the following parties were named in the lawsuit: Plaintiff: Lucille Sullivan,
15 Defendants: City and County of San Francisco, San Francisco Unified School District.
