3	Ordinance amending the Planning Code to require additional affordable housing or
4	payment of a fee for certain sites that obtained higher residential development
5	potential as a result of the rezoning of the Divisadero Street Neighborhood Commercial
6	Transit District and the Fillmore Street Neighborhood Commercial Transit District in
7	2015; affirming the Planning Department's determination under the California
8	Environmental Quality Act; and making findings of <del>consistency with the General Plan,</del>
9	<u>public convenience, necessity, and welfare under Planning Code, Section 302, and</u>
10	making findings of consistency with the General Plan, and the eight priority policies of
11	Planning Code, Section 101.1.

17	Be it ordained by the People of the City and County of San Francisco:
18	
19	Section 1. Findings.
20	(a) The Planning Department has determined that the actions contemplated in this
21	ordinance comply with the California Environmental Quality Act (California Public Resources
22	Code Sections 21000 et seq.). Said determination is on file with the Clerk of the Board of
23	Supervisors in File No. 151258 and is incorporated herein by reference. The Board affirms
24	this determination.
25	

(b) On June 30, 2016, the Planning Commission, in Resolution No. 19679, adopted
findings that the actions contemplated in this ordinance are consistent, on balance, with the
City's General Plan and eight priority policies of Planning Code Section 101.1. The Board
adopts these findings as its own. A copy of said Resolution is on file with the Clerk of the
Board of Supervisors in File No. 151258, and is incorporated herein by reference.

6 (c) Pursuant to Planning Code Section 302, this Board finds that the actions
7 contemplated in this ordinance will serve the public necessity, convenience, and welfare for
8 the reasons set forth in Planning Commission Resolution No. 19679 and the Board
9 incorporates such reasons herein by reference. A copy of the Planning Commission
10 Resolution No. 19679 is on file with the Clerk of the Board of Supervisors in File No.151258.

(d) The City adopted legislation rezoning the area along Divisadero Street between 11 12 Haight and O'Farrell Streets to become the Divisadero Street Neighborhood Commercial 13 Transit District ("NCT") in Ordinance No. 127-15 in August 2015, and the area along Fillmore Street between Bush and McAllister Streets to become the Fillmore Street NCT in Ordinance 14 15 No. 126-15 in August 2015. The rezoning for both NCTs removed any residential density 16 limits based on lot area, and instead restricted residential uses by physical envelope controls 17 like height, bulk, and setback requirements for each site. This removal of density limits based 18 on lot areas should afford allows for greater increased residential development potential on certain sites within each the Divisadero NCT. 19

(e) On November 6, 2012, the voters adopted Proposition C ("2012 Prop C"), the
Housing Trust Fund, which was set forth in San Francisco Charter Section 16.110. 2012 Prop
C established a limitation on the Inclusionary Housing Cost Obligation that the City could
impose on residential development projects. 2012 Prop C set forth certain exceptions to this
limitation, including but not limited to circumstances in which a project receives a 20% or
greater increase in developable residential uses, as measured by a change in height limits,

Floor Area Ratio limits, or use, over prior zoning, or a 50% or greater increase in residential
 densities over prior zoning, through a special use district or other local legislation adopted
 after November 6, 2012. The Divisadero Street NCT and the Fillmore Street NCT rezonings
 were was adopted after this date.

(f) In July 2017, the Board of Supervisors amended the Inclusionary Affordable 5 Housing Program, Planning Code Sections 415 et seg., and included a provision that requires 6 7 the Planning Department, in consultation with the Controller's Office, to study whether a 8 higher on-site inclusionary affordable housing requirement is feasible on sites that, after 9 January 1, 2015, received a 20% or greater increase in developable residential gross floor area or a 35% or greater increase in residential density over prior zoning. The Divisadero 10 Street NCT and the Fillmore Street NCT received a 20% or greater increase in developable 11 12 residential gross floor area or a 35% or greater increase in residential density over prior 13 zoning after January 1, 2015. Accordingly, an Inclusionary Housing Analysis of Divisadero and Fillmore Street Rezoning was published by the Office of the Controller and the Planning 14 Department on March 19, 2018, and was presented at a public hearing of the Planning 15 Commission on March 22, 2018. The study can be found in Board of Supervisors File No. 16 17 151258. The study found that sites in the Divisadero Street NCT could feasibly provide on-18 site affordable units in an amount ranging from 20% to 22% of dwelling units for Rental Housing projects, or 23% for projects consisting of Owned Units. The study found that 19 20 increased on-site affordability requirements were not financially feasible for sites in the 21 Fillmore NCT district. (g) In keeping with the intent and provisions of the Housing Trust Fund and the 2017 22 23 amendments to the Inclusionary Affordable Housing Program, projects on sites that have received increases in developable residential gross floor area or greater density should, and 24 can afford to, mitigate fully their impacts on the need for affordable housing. 25

1 (fh) The City updated its Nexus Study in November 2016, performed by Keyser 2 Marston and Associates, in support of the Inclusionary Affordable Housing Program, or an 3 analysis of the impact of development of market rate housing on affordable housing supply and demand. The Board of Supervisors reviewed the Nexus Study and staff analysis and 4 5 report of the Study and, on that basis, found that the Study supported the inclusionary 6 affordable housing requirements combined with the additional affordable housing fee set forth 7 in Planning Code Sections 415 et seq. 8 (g) On June 7, 2016, the voters approved a Charter Amendment ("2016 Prop C")

eliminating the limits on inclusionary affordable housing set forth in Charter Section 16.110.
 The Board of Supervisors also adopted legislation to implement changes to the inclusionary
 affordable housing requirements, Ordinance No. 76-16, which went into effect when 2016
 Prop C went into effect.

(h) The 2015 rezoning of the Divisadero and Fillmore NCTs allowed a 50% or greater
 increase in residential densities over prior zoning on certain sites contained within the two
 NCTs. In keeping with the intent and provisions of both 2012 Prop C and 2016 Prop C,
 projects on such sites should, and can afford to, mitigate fully their impacts on the need for
 affordable housing.

Section 2. The Planning Code is hereby amended by adding Section 428, including
Sections 428.1, 428.2, 428.3, 428.4, and 428.5, to read as follows:

## 21 <u>SEC. 428. DIVISADERO STREET NCT</u> AND FILLMORE STREET NCT <u>AFFORDABLE</u> 22 <u>HOUSING FEE AND REQUIREMENTS.</u>

- 23 <u>Sections 428.1 through 428.5, hereafter referred to as Sections 428.1 et seq., set forth the</u>
- 24 requirements and procedures for the Divisadero Street and Fillmore Street Neighborhood
- 25 <u>Commercial Transit District</u> <u>Affordable Housing Fee.</u>

1	SEC. 428.1. FINDINGS.
2	The Board of Supervisors hereby finds that:
3	<u>(a) The additional affordable housing fee requirement of this Sections 428.1 et seq. is</u>
4	supported by the November 2016 Nexus Study performed by Keyser Marston and Associates. The
5	Board of Supervisors has reviewed the Nexus Study and other documents and, on that basis, finds that
6	the Study supports the inclusionary affordable housing requirements combined with the additional
7	<u>affordable housing fee and requirements set forth in this Sections 428.1 et seq. Specifically, the Board</u>
8	finds that the Study: (1) identifies the purpose of the additional fee and requirements to mitigate
9	impacts on the demand for affordable housing in the City; (2) identifies the use of the additional fee to
10	increase the City's affordable housing supply; and (3) establishes a reasonable relationship between
11	the use of the additional fee for affordable housing and the need for affordable housing and the
12	construction of new market rate housing. Further, the affordable housing fee and requirements do not
13	include the costs of remedying any existing deficiencies and do not duplicate other City requirements or
14	<u>fees.</u>
15	(b) An account has been established, funds appropriated, and a construction schedule adopted
16	for affordable housing projects funded through the Inclusionary Affordable Housing Program. The
17	Affordable Housing Fee will reimburse the City for expenditures on affordable housing that have
18	already been made and that will be made in the future.
19	(c) A major objective of the Divisadero Street and Fillmore Street <u>NCTs, set forth in Planning</u>
20	<u>Code Sections 746 759 and 747, respectively, is to encourage and promote development that</u>
21	enhances the walkable, mixed-use character of the corridor and surrounding neighborhood <del>s</del> and to
22	encourage housing development in new buildings above the ground floor. New market rate housing
23	development could outnumber both the number of units and potential new sites within the area for
24	permanently affordable housing opportunities. The City has adopted a policy in its General Plan to
25	meet the affordable housing needs of its general population and to require new housing developments

1	to produce sufficient affordable housing opportunities for all income groups, both of which goals are
2	not likely to be met by the potential housing development in the area. In addition, the Nexus Study
3	indicates that market rate housing itself generates additional lower income affordable housing needs
4	for the workforce needed to serve the residents of the new market rate housing proposed for the area.
5	To meet the demand created for affordable housing by the Divisadero Street NCT and Fillmore Street
6	NCT zoning and to be consistent with the policy of the City, additional affordable housing
7	<u>requirements should be included for all market rate housing development in these this NCTs.</u>
8	(d) The Divisadero Street NCT and Fillmore Street NCT rezonings set forth in Ordinance
9	<u>No</u> s. 126-15 and <u>127-15</u> will allows greater residential development on certain sites within the NCTs,
10	and such residential development will create a greater need for affordable housing, and should provide
11	more affordable housing. The higher densities will also make provision of higher levels of affordable
12	housing feasible for such sites.
13	(e) If a site located in the Divisadero Street NCT or Fillmore Street NCT received an increase
14	<u>in density of 50% or more from the 2015 rezoning set forth in Ordinance No</u> s. 126-15 and 127-15, a
15	higher inclusionary affordable housing requirement should apply. The density for the previously
16	<u>existing Divisadero Street Neighborhood Commercial District was one unit per 800 square feet of lot</u>
17	area. The density for the Fillmore Neighborhood Commercial District was 1 unit per 600
18	square feet of lot area, with one parcel (Block 0798, Lot 001) zoned RH-3 (3 units per lot),
19	another parcel (Block 0779, Lot 031) zoned RM-4 (1 unit per 200 square feet of lot area), and
20	one parcel (Block 0702, Lot 038) zoned RM-3 (1 unit per 400 square feet of lot area).
21	SEC. 428.2. DEFINITIONS.
22	See Section 401 of this Article 4.
23	SEC. 428.3. APPLICATION OF AFFORDABLE HOUSING FEE REQUIREMENT.
24	(a) Applicability. The Inclusionary Affordable Housing Program set forth in Planning
25	Code Sections 415.1 et seq. shall apply in the Divisadero Street NCT and Fillmore Street

1	NCT, with the following requirements that will apply to certain sites in these NCTs. In the
2	event that the Planning Department determines that the residential development potential on
3	a site within the Divisadero Street NCT or the Fillmore Street NCT has been increased
4	through the adoption of the NCT rezoning set forth in Ordinance Nos. 126-15 and 127-15, as
5	detailed in Section 428.1(e) herein, the requirements of Sections 415.1 through 415.9 of the
6	Planning Code shall apply, except that the "grandfathering" provisions of Planning Code
7	Section 415.3(b) shall not apply to such sites and the following affordable housing
8	requirements shall be applied to residential development on such sites:
9	(1) Fee. For a development project that is subject to the Residential
10	Inclusionary Affordable Housing Program, the development project shall pay an affordable
11	housing fee equivalent to a requirement to provide 30% of the units in the principal project as
12	affordable units, using the method of fee calculation set forth in Section 415.5(b).
13	(2) On-Site Housing. If the project sponsor of a housing development project is
14	eligible and elects to construct units affordable to qualifying households on-site of the principal
15	project as set forth in Planning Code Section 415.5(g), the project sponsor shall construct a
16	total of 23% of all units constructed on the project site as affordable housing and shall comply
17	with all otherwise applicable requirements of Section 415.6. The on-site affordable units shall
18	be affordable as follows. A minimum of 6% of the units shall be affordable to households
19	earning up to 55% of Area Median Income, and 8% of the units shall be affordable to
20	households earning up to 120% of Area Median Income, and 9% of the units shall be
21	affordable to households earning up to 140% of Area Median Income.
22	(3) Off-Site Housing. If the project sponsor of a housing development project is
23	eligible and elects to provide units affordable to qualifying households off-site of the principal
24	project as set forth in Section 415.5(g), the project sponsor shall construct or cause to be
25	constructed affordable housing equal to 30% of all units constructed on the principal project

site as affordable housing and shall comply with all otherwise applicable requirements of
 Section 415.7.

3	(a) For any project for which a complete development application has been submitted
4	before October 1, 2018, the Inclusionary Affordable Housing Program set forth in Planning
5	Code Sections 415.1 et seq. shall apply in the Divisadero Street NCT, except the temporary
6	provisions of Planning Code Section 415.3(b) shall not apply and except as set forth in section
7	Section 428.3(a). For any development site for which the Planning Department determines
8	that the residential development potential within the Divisadero Street NCT has been
9	increased through the adoption of the NCT rezoning set forth in Ordinance No. 127-15, as
10	detailed in Section 428.1(e) herein, the requirements of Sections 415.1 et seq of the Planning
11	Code shall apply, except as set forth in subsections (a)(1), (a)(2) and (a)(3), below, and the
12	temporary provisions of Planning Code Section 415.3(b) shall not apply.
13	(1) Fee. For a development project of 10 or more dwelling units that is subject
14	to the Inclusionary Affordable Housing Program, the development project shall pay an
15	affordable housing fee equivalent to a requirement to provide 33% of the units in the principal
16	project as affordable units if those units are Owned Units, or 30% of the units if the project is a
17	Rental Housing Project, using the method of fee calculation set forth in Section 415.5(b).
18	(2) On-site. For a development project of 10 or more units that is subject to the
19	Inclusionary Affordable Housing Program that elects to construct units affordable to qualifying
20	households on-site of the principal project as set forth in Planning Code Section 415.5(g), the
21	development project shall comply with all otherwise applicable requirements of Section 415.6.
22	except that for all housing development projects consisting of 10 or more units, the following
23	requirements shall apply.
24	(A) For a housing development project consisting of Owned Units, the
25	number of affordable units constructed on site shall be 23% of all units constructed on the

1 site. A minimum of 12% of the units shall be affordable to low-income households, 5.5% of 2 the units shall be affordable to moderate-income households, and 5.5% of the units shall be affordable to middle-income households. In no case shall the total number of affordable units 3 required exceed the number required as determined by the application of the applicable on-4 site requirement rate to the total project units. Owned Units for low-income households shall 5 6 have an affordable purchase price set at 80% of Area Median Income or less, with 7 households earning up to 100% of Area Median Income eligible to apply for low-income units. 8 Owned Units for moderate-income households shall have an affordable purchase price set at 9 105% of Area Median Income or less, with households earning from 95% to 120% of Area Median Income eligible to apply for moderate-income units. Owned Units for middle-income 10 households shall have an affordable purchase price set at 130% of Area Median Income or 11 12 less, with households earning from 120% to 150% of Area Median Income eligible to apply for 13 middle-income units. (B) For a Rental Housing Project, the number of affordable units 14 constructed on site shall be 20% of all units constructed on the site. A minimum of 12% of the 15 units shall be affordable to low-income households, 4% of the units shall be affordable to 16 moderate-income households, and 4% of the units shall be affordable to middle-income 17 18 households. In no case shall the total number of affordable units required exceed the number required as determined by the application of the applicable on-site requirement rate to the 19 20 total project units. Rental Units for low-income households shall have an affordable rent set at 21 55% of Area Median Income or less, with households earning up to 65% of Area Median Income eligible to apply for low-income units. Rental Units for moderate-income households 22 23 shall have an affordable rent set at 80% of Area Median Income or less, with households earning from 65% to 90% of Area Median Income eligible to apply for moderate-income units. 24 25 Rental Units for middle-income households shall have an affordable rent set at 110% of Area

<u>Median Income or less, with households earning from 90% to 130% of Area Median Income</u>
 eligible to apply for middle-income units.

(3) Off-site. If the project sponsor of a housing development project of 10 or 3 more units that is subject to the Inclusionary Affordable Housing Program elects to provide 4 units affordable to qualifying households off-site of the principal project as set forth in 5 6 Section 415.5(g), the project sponsor shall construct or cause to be constructed affordable 7 housing equal to 33% of all units constructed on the principal project site as affordable 8 housing if the units in the principal project are owned units, and 30 % if the project is a Rental 9 Housing Project. (b) For any project for which a complete development application has been submitted 10 on or after October 1, 2018, the Inclusionary Affordable Housing Program set forth in Planning 11 12 Code Sections 415.1 et seg, shall apply in the Divisadero Street NCT except as set forth in 13 this subsection (b). For any development site for which the Planning Department has determined that the residential development potential has been increased through the 14 adoption of the NCT rezoning set forth in Ordinance No. 127-15, as detailed in Section 15 428.1(e) herein, the requirements of Planning Code Sections 415.1 et seg. shall apply, except 16 17 that the following affordable housing requirements shall be applied to residential development 18 on such sites: (1) Fee. For a development project of 10 or more dwelling units that is subject 19 20 to the Inclusionary Affordable Housing Program, the development project shall pay an 21 affordable housing fee equivalent to a requirement to provide 33% of the units in the principal project as affordable units if those units are Owned Units, or 30% of the units if the project is a 22 23 Rental Housing Project, using the method of fee calculation set forth in Section 415.5(b). (2) On-site. If the housing development project of 10 or more dwelling units that 24 is subject to the Inclusionary Affordable Housing Program elects to construct units affordable 25

1 to qualifying households on-site of the principal project as set forth in Planning Code Section

- 2 <u>415.5(g), the project sponsor shall comply with all otherwise applicable requirements of</u>
- 3 Section 415.6, except that for all housing development projects consisting of 10 or more units.
- 4 <u>the number of affordable units constructed on-site shall be provided as follows.</u>
- <u>(A) A project that consists of Owned Units shall provide 23% of units as</u>
  <u>affordable units at the following levels: ten percent 10% shall have an average affordable</u>
  <u>purchase price set at 80% of Area Median Income; 8% shall have an average affordable</u>
  <u>purchase price set at 105% of Area Median Income; and 5% shall have an average affordable</u>
  <u>purchase price set at 130% of Area Median Income.</u>
  (B) A project that consists of Rental Units shall provide 23% of units as-in
- 11 the affordable units at the following levels: ten percent 10% shall have an average affordable
- 12 rent set at 55% of Area Median Income; 8% shall have an average affordable rent set at 80%
- 13 of Area Median Income; and 5% shall have an average affordable rent set at 110% of Area
- 14 <u>Median Income.</u>
- (C) Notwithstanding subsections (b)(2)(A) and (b)(2)(B), the percentage 15 and affordability levels of affordable units constructed on-site as set forth in subsections 16 17 (b)(2)(A) and (b)(2)(B) shall be the same percentage and affordability levels as set forth in 18 Section 206.3(f)(2)(A), as it may be amended from time to time, and in no case shall the percentage of affordable units constructed on-site pursuant to this subsection (b)(2) be less 19 20 than the percentage required by Section 415.6 for projects consisting of 25 or more units. If 21 the percentage of affordable units constructed on-site pursuant to this subsection (b)(2) would be less than the percentage set forth in Section 415.6 for projects consisting of 25 or more 22 23 units, the percentage of affordable units set forth in Section 415.6 for projects consisting of 25
- 24 or more units shall apply.
- 25

1	(3) Off-site. If the project sponsor of a housing development project of 10 or
2	more units is eligible and elects to provide units affordable to qualifying housing households
3	off-site of the principal project as set forth in Section 415.5(g), the project sponsor shall
4	construct or cause to be constructed affordable housing equal to 33% of all units constructed
5	on the principal project site as affordable housing if the units in the principal project are owned
6	units, and 30% if the project is a Rental Housing Project.
7	(b) Exemption for Affordable Housing. A project applicant shall not pay the affordable
8	housing fee for any space designated as a below market rate unit under Section 415.1 et
9	seq., the Citywide Inclusionary Affordable Housing Program, or any other residential unit that
10	is designated as an affordable housing unit under a Federal, State, or local restriction in a
11	manner that maintains affordability for a term no less than 50 years.
12	(c) If the Board adopts higher inclusionary housing requirements, the higher
13	requirement shall apply.
14	SEC. 428.4. IMPOSITION OF AFFORDABLE HOUSING REQUIREMENTS.
15	(a) Determination of Requirements. The Planning Department shall determine the
16	applicability of Section <u>s</u> 428.1 et seq. to any development project requiring a first construction
17	<u>document and, if Sections 428.1 et seq. is applicable applies, shall impose any such requirements as a</u>
18	condition of approval for issuance of the first construction document. The project sponsor shall supply
19	any information necessary to assist the Department in this determination.
20	(b) Department Notice to Development Fee Collection Unit of Fee Requirements. After the
21	Department has made its final determination regarding the application of the affordable housing
22	<u>requirements to a development project pursuant to Section§ 428.1 et seq., it shall immediately notify</u>
23	the Development Fee Collection Unit at DBI of the applicable affordable housing fee amount in
24	addition to the other information required by Planning Code Section 402(b).
25	

1	(c) Process for Revisions of Determination of Requirements. If the Department or the
2	<u>Commission takes action affecting any development project subject to Sections</u> 428.1 et seq. and such
3	action is subsequently modified, superseded, vacated, or reversed by the Board of Appeals, the Board
4	of Supervisors, or a court, the procedures of Planning Code Section 402(c) shall be followed.
5	<u>SEC. 428.5. USE OF FUNDS.</u>
6	<u>The affordable housing fee specified in this Sections 428.1 et seq. for the Divisadero Street</u>
7	<u>NCT and the Fillmore Street NCT shall be paid into the Citywide Affordable Housing Fund,</u>
8	established in Administrative Code Section 10.100-49, and the funds shall be separately accounted for.
9	The Mayor's Office of Housing and Community Development shall expend the funds to increase the
10	supply of housing affordable to qualifying households in the City. The funds may also be used for
11	monitoring and administrative expenses subject to the process described in Planning Code Section
12	<u>415.5(f).</u>
13	
14	Section 3. The Planning Code is hereby amended by revising Sections <u>759</u> 746 and
15	747, to read as follows:
16	SEC. 746 759. DIVISADERO STREET NEIGHBORHOOD COMMERCIAL TRANSIT
17	DISTRICT.
18	The Divisadero Street Neighborhood Commercial Transit District ("Divisadero Street
19	NCT") extends along Divisadero Street between Haight and O'Farrell Streets. Divisadero
20	Street's dense mixed-use character consists of buildings with residential units above ground-
21	story commercial use. Buildings typically range in height from two to four stories with
22	occasional one-story commercial buildings. The district has an active and continuous
23	commercial frontage along Divisadero Street for most of its length. Divisadero Street is an
24	important public transit corridor and throughway street. The commercial district provides
25	

convenience goods and services to the surrounding neighborhoods as well as limited
 comparison shopping goods for a wider market.

The Divisadero Street NCT controls are designed to encourage and promote development that enhances the walkable, mixed-use character of the corridor and surrounding neighborhoods. Rear yard requirements above the ground story and at residential levels preserve open space corridors of interior blocks. Housing development in new buildings is encouraged above the ground story. Existing residential units are protected by limitations on demolition and upper-story conversions.

9 Consistent with Divisadero Street's existing mixed-use character, new commercial development is permitted at the ground and second stories. Most neighborhood-serving 10 11 businesses are strongly encouraged. Controls on new Formula Retail uses are consistent with 12 Citywide policy for Neighborhood Commercial Districts; Eating and Drinking and 13 Entertainment uses are confined to the ground story. The second story may be used by some 14 retail stores, personal services, and medical, business and professional offices. Additional 15 flexibility is offered for second-floor Eating and Drinking, Entertainment, and Trade Shop uses 16 in existing non-residential buildings to encourage the preservation and reuse of such 17 buildings. Hotels are monitored at all stories. Limits on late-night activity, drive-up facilities, 18 and other automobile uses protect the livability within and around the district, and promote 19 continuous retail frontage.

20

If the Planning Department determines that any site proposed for residential development and

- 21 *located within the Divisadero Street NCT has received a 50% or greater increase in residential*
- 22 *densities over prior zoning through the adoption of Ordinance No. 127-15, any development project*
- 23 *that is subject to the Inclusionary Affordable Housing Program on such site shall pay the Affordable*

The Planning Code is hereby amended by revising Section 415.3(b), to 5 6 read as follows: 7 <u>(b)</u> \* \* \* \* 8 9 (3) During the limited period of time in which the provisions of Section 415.3(b) 10 apply, for any housing development that is located in an area with a specific affordable housing requirement set forth in an Area Plan or a Special Use District, or in any other section 11 12 of the Code such as Section 419, with the exception of the UMU Zoning District or in the 13 South of Market Youth and Family Zoning District, the higher of the affordable housing requirement set forth in such Area Plan or Special Use District or in Section 415.3(b) shall 14 15 apply. Upon introduction, this ordinance proposed revising Planning Code Section 22 23 747. At its regular meeting on November 13, 2018, the Board of Supervisors amended this ordinance to remove Section 747, such that this ordinance no longer includes that Section. 24 25

1	Section 56. Effective Date. This ordinance shall become effective 30 days after
2	enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the
3	ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board
4	of Supervisors overrides the Mayor's veto of the ordinance.
5	
6	Section 67. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors
7	intends to amend only those words, phrases, paragraphs, subsections, sections, articles,
8	numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal
9	Code that are explicitly shown in this ordinance as additions, deletions, Board amendment
10	additions, and Board amendment deletions in accordance with the "Note" that appears under
11	the official title of the ordinance.
