We are writing to respectively request approval to transfer our existing Type 48 Liquor License to St Joseph's Art Society, located at 1401 Howard St, San Francisco.

This license was in operation at our cocktail bar, Rosewood, located at 732 Broadway, from 2000 until the building was sold and we were forced to vacate in 2014. Throughout those 14 years, Rosewood operated with zero infractions and received broad support from local residents, merchants, District 3 Supervisors, and Central Station Police.

Since 2015 we have actively searched for a new location to transfer our license. Unfortunately, this search has coincided with limited inventory and uncommonly high commercial rent.

For those unfamiliar, St Joseph's Art Society is the ambitious and meticulous restoration of the abandoned landmark structure formerly known as St Joseph's Catholic Church. The esteemed gallery, Carpenter's Workshop, has taken up residency on the mezzanine of SJAS and currently showcasing a varied list of fine artists and sculptors.

In partnership with St Joseph's Art Society, we have have enthusiastically and tirelessly embraced the local community to share our vision and listen openly to any concerns. We have received overwhelming and unanimous support from the neighborhood and greater SOMA. Our two closest neighbors and supporters are Love & Learn Nursery School and Presidio Knolls School.
