

1 [Agreement Amendment - Cross Country Staffing, Inc. - Department of Public Health Registry
2 Services - Not to Exceed \$24,652,390]

3 **Resolution approving an Amendment No. 1 to the agreement between the Cross**
4 **Country Staffing, Inc. and the Department of Public Health, for as-needed registry**
5 **personnel to respond to the increase in patient census at Zuckerberg San Francisco**
6 **General Hospital and for a technical adjustment to the contract, to increase the**
7 **agreement amount by \$14,812,390 for an amount not to exceed \$24,652,390 with no**
8 **change to the term length to expire on June 30, 2019, to commence upon approval by**
9 **the Board of Supervisors.**

11 WHEREAS, DPH desires to continue to acquire registry services in order to meet all
12 mandated minimum staffing levels in order to continue to deliver a high quality of care to
13 patients of the Department of Public Health and Zuckerberg San Francisco General hospital
14 and medical center (ZSFG); and

15 WHEREAS, Section 21A.2.b of the Administrative Code allows for DPH to utilize all
16 programs and services of a Government Purchasing Organization (GPO), including utilizing
17 the results of the competitive solicitations conducted by the GPO; and

18 WHEREAS, DPH is a member of Vizient, a GPO, as authorized under Section 21A.2 of
19 the Administrative Code; and

20 WHEREAS, ZFGH has experienced an average increase of 33 beds per year to date
21 for Fiscal Year 2019 which has increased patient census at ZFGH; and

22 WHEREAS, There is a need for a technical adjustment in the contract budget to
23 account for incorrectly processed invoices against the current year contract; and

24 WHEREAS, The cost of the two year term of the amended contract will not exceed
25 \$24,652,390; and

1 WHEREAS, A copy of the original agreement is on file with the Clerk of the Board of
2 Supervisors in File No. _____, which is hereby declared to be part of this Resolution as
3 if set forth fully herein; and

4 WHEREAS, When the amended contract is fully signed and certified, a copy will be on
5 file with the Clerk of the Board of Supervisors in File No. _____, which is hereby
6 declared to be a part of this resolution as if set forth fully herein; now, therefore, be it

7 RESOLVED, That the Board of Supervisors hereby authorizes the Department of
8 Public Health to amend the contract with Cross Country Staffing, Inc. to increase the
9 agreement amount by \$14,812,390 for an amount not to exceed \$24,652,390.

10 FURTHER RESOLVED, That the Board of Supervisors authorizes the
11 Department of Public Health to enter into any amendments or modifications to the
12 contract, prior to its final execution by all parties, that the Department determines, in
13 consultation with the City Attorney, are in the best interest of the City, do not otherwise
14 materially increase the obligations or liabilities of the City, are necessary or advisable to
15 effectuate the purposes of the contract, and are in compliance with all applicable laws;
16 and, be it

17 FURTHER RESOLVED, That within thirty (30) days of the contract being fully executed
18 by all parties, the Director of Health and/or the Director of the Office of Contract
19 Administration/Purchaser shall provide the final contracts to the Clerk of the Board for
20 inclusion into the official File No. _____.
