**Contract No. 10401.45  
Capital Program Support Services for the  
Airport Capital Improvement Program**

THIS MODIFICATION (this "Modification") is made as of October 16, 2018, in San Francisco, California, by and between **Hill International, Inc.** ("Contractor"), and the City and County of San Francisco, a municipal corporation ("City"), acting by and through its Airport Commission, hereinafter referred to as "**Commission.**"

RECITALS

- A. City and Contractor have entered into the Agreement (as defined below); and
- B. On October 17, 2017, by Resolution No. 17-0251, the Commission awarded this Agreement to the Contractor for one (1) year of service in a not-to-exceed amount of \$8,500,000; and
- C. On March 1, 2018, the City and Contractor administratively modified the Agreement to add a new sub-consultant through Modification No. 1; and
- D. On April 16, 2018, the City and Contractor administratively modified the Agreement to add a new sub-consultant through Modification No. 2; and
- E. On October 16, 2018, by Resolution No. 18-0350, the Commission approved Modification No. 3 to extend the term of the agreement through June 30, 2019 and to increase the amount by \$1,450,000 for a new not-to-exceed amount of \$9,950,000. Labor rates were also updated in Modification No. 3; and
- F. City and Contractor desire to modify the Agreement on the terms and conditions set forth herein to extend the term of the agreement and increase the contract amount; and
- G. On October 16, 2018, by Resolution No. 18-0350, the Commission approved this Modification No. 4 to extend the term of the agreement for services through November 15, 2023 and increase the amount by \$30,050,000 for a new not-to-exceed amount of \$40,000,000; and
- H. On \_\_\_\_\_, by Resolution No. \_\_\_\_\_, the Board of Supervisors approved the Agreement under San Francisco Charter Section 9.118; and
- I. Approval for this Agreement was obtained when the Department of Human Resources approved Modification No. 2 to PSC No. 40890-14/15 on September 24, 2018; and

NOW, THEREFORE, Contractor and the City agree as follows:

- 1. Definitions.** The following definitions shall apply to this Modification:

**a. Agreement.** The term “Agreement” shall mean the Agreement dated October 17, 2017 between Contractor and City, as amended by the:

Modification No. 1,	dated March 1, 2018,
Modification No. 2,	dated April 16, 2018, and
Modification No. 3,	dated October 16, 2018.

**b. Other Terms.** Terms used and not defined in this Modification shall have the meanings assigned to such terms in the Agreement.



**2. Section 2. Term of the Agreement** is hereby amended to extend the term of the contract for services through **November 15, 2023**.

**3. Section 5. Compensation** is hereby amended to increase the total compensation payable by an amount not to exceed **Thirty Million Fifty Thousand Dollars (\$30,050,000)** for a new total not to exceed amount of **Forty Million Dollars (\$40,000,000)**.

**4. Effective Date.** Each of the changes set forth in this Modification shall be effective on and after the date of this Modification.

**5. Legal Effect.** Except as expressly changed by this Modification, all of the terms and conditions of the Agreement shall remain unchanged and in full force and effect.
