THIS MODIFICATION (this "Modification") is made as of **March 1, 2018**, in San Francisco, California, by and between **Hill International, Inc.** ("Contractor"), and the City and County of San Francisco, a municipal corporation ("City"), acting by and through its Airport Commission, hereinafter referred to as "**Commission**."

RECITALS

- A. City and Contractor have entered into the Agreement (as defined below); and
- B. On October 17, 2017, by Resolution No. 17-0251, the Commission awarded this Agreement to the Contractor for one (1) year of service in a not-to-exceed amount of \$8,500,000; and
- C. City and Contractor desire to administratively modify the Agreement on the terms and conditions set forth herein to add a new sub-consultant: and
- D. Approval for this Agreement was obtained when the Civil Service Commission approved PSC No. 40890-14/15 on February 6, 2017; and

NOW, THEREFORE, Contractor and the City agree as follows:

- 1. **Definitions.** The following definitions shall apply to this Modification:
- **a. Agreement.** The term "Agreement" shall mean the Agreement dated October 17, 2017 between Contractor and City.
- **b.** Other Terms. Terms used and not defined in this Modification shall have the meanings assigned to such terms in the Agreement.
- **2. Appendix B, Calculation of Charges,** is hereby amended as follows:
 - a. Paragraph 1.1 is hereby deleted in its entirety and replaced with the following:
 - 1.1 As set forth in in Article 3.3 "Compensation" of the Agreement, Compensation for work performed under this Agreement will be on a time and materials or on a lump sum basis, if approved by the Airport Project Manager, and is broken down as follows for the first year of services:

Mobilization (Lump Sum) =

\$311,000

Professional Services and Other Direct Costs (ODCs) = \$8,189,000

Total First Year of Services = \$8,500,000

b. Paragraph 3.1.3 is hereby amended to update the Schedule Manager's labor rate as follows:
