THIS MODIFICATION (this "Modification") is made as of **April 16, 2018**, in San Francisco, California, by and between **Hill International, Inc.** ("Contractor"), and the City and County of San Francisco, a municipal corporation ("City"), acting by and through its Airport Commission, hereinafter referred to as "**Commission.**"

RECITALS

- A. City and Contractor have entered into the Agreement (as defined below); and
- B. On October 17, 2017, by Resolution No. 17-0251, the Commission awarded this Agreement to the Contractor for one (1) year of service in a not-to-exceed amount of \$8,500,000; and
- C. On March 1, 2018, the City and Contractor administratively modified the Agreement to add a new sub-consultant through Modification No. 1; and
- D. City and Contractor desire to administratively modify the Agreement on the terms and conditions set forth herein to add a new sub-consultant; and
- E. Approval for this Agreement was obtained when the Civil Service Commission approved PSC No. 40890-14/15 on February 6, 2017; and

NOW, THEREFORE, Contractor and the City agree as follows:

- 1. **Definitions.** The following definitions shall apply to this Modification:
 - a. **Agreement.** The term "Agreement" shall mean the Agreement dated October 17, 2017 between Contractor and City, as amended by the:

Modification No. 1, dated March 1, 2018.
 - b. **Other Terms.** Terms used and not defined in this Modification shall have the meanings assigned to such terms in the Agreement.
- 2. **Appendix B, Calculation of Charges,** is hereby amended as follows:
 - a. **Paragraph 3.1.3** is hereby amended to update the Program Advisor III's labor rate as follows:

- b. Paragraph 3.2.1 is hereby amended to include a new sub-consultant, gkkworks – CannonDesign, as follows:

3. **Effective Date.** Each of the changes set forth in this Modification shall be effective on and after the date of this Modification.
