## ORDINANCE NO.

[Settlement of Lawsuit - Lucille Sullivan - \$40,000]

Ordinance authorizing settlement of the lawsuit filed by Lucille Sullivan against the City and County of San Francisco for \$40,000; the lawsuit was filed on July 3, 2017, in San Francisco Superior Court, Case No. CGC-17-559902; entitled <u>Lucille Sullivan v. City and</u> <u>County of San Francisco</u>; the lawsuit involves a personal injury on a City sidewalk.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>Lucille Sullivan v. City and County of San Francisco</u>, San Francisco Superior Court, Case No. CGC-17-559902 by the payment of \$40,000. The lawsuit involves a trip and fall.
