3 **Resolution approving the Terminal 2 Specialty Retail Concession Lease No. 5 -**

6 **of seven years to commence upon approval by the Board of Supervisors, and a**

9 WHEREAS, Upon completion of a competitive selection process, the Airport
10 Commission adopted Resolution No. 18-0156 on May 15, 2018, awarding the Terminal 2
11 Specialty Retail Concession Lease No. 5 to XpresSpa S.F. International, LLC; and

12 WHEREAS, The Terminal 2 Specialty Retail Concession Lease No. 5 has a term of
13 seven years, and an initial minimum annual guarantee of \$145,000; now, therefore, be it

14 RESOLVED, That this Board of Supervisors hereby approves the Terminal 2 Specialty
15 Retail Concession Lease No. 5, a copy of which is on file with the Clerk of the Board of
16 Supervisors in File No. 180824; and, be it

17 FURTHER RESOLVED, That within thirty (30) days of the lease being fully-executed by
18 all parties, the Airport Commission shall provide the final lease to the Clerk of the Board for
19 inclusion into the official file.


