Hi Fred,

Great news! While not official, because we haven't received the final contract, it looks like we'll be awarded a new grant from GOBIZ (see below). I'm sending you the proposal we submitted to GOBIZ in the attachment. This grant will, in short, expand the services we already offer, allowing us to 1) serve a greater number of businesses, 2) dive in deeper with clients, and 3) explore new opportunities that were previously unavailable to us due to limited funding (such as online training). Finally, there's more flexibility with this award as it is not limited to access to capital services; also, we'll have some ability to roll over the funding into future years (if need be).

Additionally, our previous GOBIZ contract was increased to \$62,500. Aside from the grant amount, there will be no other changes to this contract.

Again, we are waiting for the financial contracts, but it looks like the total will be approximately \$266,417.50.

I know we'll need to introduce this for Supervisor's approval. Please advise on next steps, or let me know if you have any questions. We can also meet if you would like to discuss in detail.
