16 Be it ordained by the People of the City and County of San Francisco:

17 Section 1. Findings.

18 (a) The Planning Department has determined that the actions contemplated in this  
19 ordinance comply with the California Environmental Quality Act (California Public Resources  
20 Code Sections 21000 et seq.). Said determination is on file with the Clerk of the Board of  
21 Supervisors in File No. 180969 and is incorporated herein by reference. The Board affirms  
22 this determination.

23 (b) On September 19, 2018, the Building Inspection Commission considered this  
24 ordinance at a duly noticed public hearing pursuant to Charter Section D3.750-5.

25 (c) No findings are required for this ordinance under Section 17958.7 of the California  
Health and Safety Code because the ordinance deletes a local amendment to the California  
Plumbing Code.

1 Section 2. Section 603.0 of the Plumbing Code is hereby amended by deleting Section  
2 603.3, as follows:

3 **SEC. 603.0 – CROSS-CONNECTION CONTROL**

4 \* \* \* \*

5 ~~603.3 Add a new second paragraph to this section as follows:~~

6 ~~Refer to SFPUC's Rules & Regs Section "A and/or G Cross connection Control", Table I and~~  
7 ~~Table 603.2 of the CPC. The more stringent shall apply.~~

8 \* \* \* \*


9 Section 3. Effective Date. This ordinance shall become effective 30 days after  
10 enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the  
11 ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board  
12 of Supervisors overrides the Mayor's veto of the ordinance.

13 Section 4. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors  
14 intends to amend only those words, phrases, paragraphs, subsections, sections, articles,  
15 numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal  
16 Code that are explicitly shown in this ordinance as additions, deletions, Board amendment  
17 additions, and Board amendment deletions in accordance with the "Note" that appears under  
18 the official title of the ordinance.

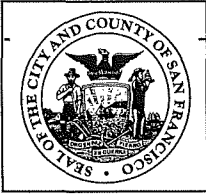
19 Section 5. Directions to Clerk. The Clerk of the Board of Supervisors is hereby

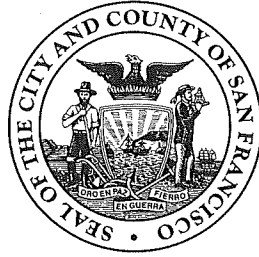

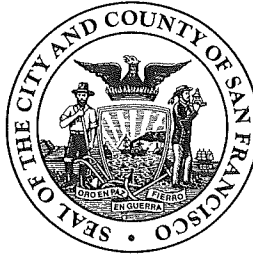
