ORDINANCE NO.

[Settlement of Lawsuit - Philadelphia Indemnity Insurance Company - \$780,000]

Ordinance authorizing settlement of the lawsuit filed by City and County of San Francisco against the Philadelphia Indemnity Insurance Company for \$780,000; the lawsuit was filed on October 2, 2015, in United States District Court, Case No. 15-cv-04557; entitled <u>City and County of San Francisco v. Philadelphia Indemnity</u> <u>Insurance Company</u>; the lawsuit involves a dispute over whether the City is covered under the terms of a commercial liability insurance policy.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>City and County of San Francisco v.</u> <u>Philadelphia Indemnity Insurance Company</u>, United States District Court, Case No. 15-cv-04557 by the payment of \$780,000. The lawsuit involves a dispute over whether the City is covered as an additional insured under a commercial liability insurance policy issued by Philadelphia Indemnity Insurance Company.

Section 2. The above-named action was filed in United States District Court on October 2, 2015, and the following parties were named in the lawsuit: plaintiff: City and County of San Francisco; defendant: Philadelphia Indemnity Insurance Company.
