8	Be it ordained by the People of the City and County of San Francisco:

10	Section 1.
11	The Planning Department has determined that the actions contemplated in this
12	ordinance comply with the California Environmental Quality Act (California Public Resources
13	Code Sections 21000 et seq.). Said determination is on file with the Clerk of the Board of
14	Supervisors in File No. and is incorporated herein by reference. The Board
15	affirms this determination.
16	
17	Section 2. The Police Code is hereby amended by revising Section 1622, to read as
18	follows:
19	SEC. 1622. DELIVERIES OF CANNABIS AND CANNABIS PRODUCTS TO
20	CUSTOMERS.
21	* * *
22	(b) Permitted Cannabis Businesses that receive authorization from the Director to
23	engage in Deliveries must comply with such Delivery Standards as may be adopted by the
24	Director, including but not limited to the following:
25	* * * *

(10) A manifest must be created for each Delivery or series of Deliveries prior to
departure completion of that Delivery or series of Deliveries, and the Delivery employee may
not make any unnecessary stops between Deliveries or deviate substantially from the
manifest route, unless a stop is necessary for personal safety.

Section 3. Procedural History. As introduced, this ordinance proposed revising Police Code Sections 1602, 1604, 1605, 1606, 1608, 1609, 1613, 1618, 1622, 1627, 1628, and 1629, as well as Health Code Section 3322. At its special meeting on December 3, 2018, the Rules Committee duplicated the file, and amended this ordinance to remove all amendments except certain amendments to Police Code Section 1622 (reflected above), such that this ordinance amends only Section 1622.

Section 4. Effective Date. This ordinance shall become effective 30 days after enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board of Supervisors overrides the Mayor's veto of the ordinance.

Section 5. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors intends to amend only those words, phrases, paragraphs, subsections, sections, articles, numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal Code that are explicitly shown in this ordinance as additions, deletions, Board amendment additions, and Board amendment deletions in accordance with the "Note" that appears under the official title of the ordinance.

## **LEGISLATIVE DIGEST**

#### Existing Law

Under Section 1622 of the Police Code, cannabis business engaged in delivery must create a manifest prior to the departure of a delivery vehicle. An employee engaged in deliveries may not deviate substantially from the manifest route, unless a stop is necessary for personal safety.

#### Amendments to Current Law

This ordinance amends Section 1622 of the Police Code to require that a manifest be created prior to the completion of a delivery or series of deliveries, rather than prior to departure of a

delivery vehicle. Additionally, the ordinance eliminates the prohibition against substantial deviation from the manifest route.

## **Background**

As introduced, the ordinance in Board File No. 180912 proposed a wide range of amendments to various provisions of the Police and Health Codes regulating commercial cannabis activity. In the course of considering that ordinance at its special meeting on December 3, 2018, the Rules Committee duplicated the file, and amended this ordinance to remove all amendments except certain amendments (described above) relevant to the regulation of cannabis deliveries under Section 1622 of the Police Code.
