## AMENDMENT OF THE WHOLE 1/10/19 RESOLUTION NO.

 [Sale of Taxable General Obligation Bonds - (Social Bonds - Affordable Housing, 2016), Series 2019A - Not to Exceed \$75,000,000]

3 Resolution authorizing the issuance and sale of not to exceed \$75,000,000 aggregate 4 principal amount of City and County of San Francisco Taxable General Obligation 5 Bonds (Social Bonds - Affordable Housing, 2016), Series 2019A; prescribing the form 6 and terms of said bonds; providing for the appointment of depositories and other 7 agents for said bonds; providing for the establishment of accounts related to said 8 bonds; authorizing the sale of said bonds by competitive or negotiated sale; approving 9 the forms of Official Notice of Sale and Notice of Intention to Sell Bonds and directing 10 the publication of the Notice of Intention to Sell Bonds; approving the form of Bond 11 Purchase Contract; approving the form of the Preliminary Official Statement and the 12 form and execution of the Official Statement relating to the sale of said bonds; 13 approving the form of the Continuing Disclosure Certificate; authorizing and approving 14 modifications to documents; ratifying certain actions previously taken, as defined 15 herein; and granting general authority to City officials to take necessary actions in 16 connection with the authorization, issuance, sale, and delivery of said bonds, as 17 defined herein.

WHEREAS, By Ordinance No. 217-92 adopted by the Board of Supervisors on July 13, 1992 (the "1992 Bond Ordinance"), the Board of Supervisors duly called a special election to be held on November 3, 1992, for the purpose of submitting to the electors of the City a proposition to incur bonded indebtedness of the City in the amount of up to \$350,000,000 of general obligation bonds to establish a seismic safety loan program (the "Loan Program") to provide loans for the seismic strengthening of unreinforced masonry buildings; and /// WHEREAS, A special election was held in the City on November 3, 1992 (the "Proposition A Bond Election"), for the purpose of submitting to the qualified voters of the City

3 said proposition, denominated as Proposition A ("Proposition A"), as follows:

4 "EARTHQUAKE LOAN BOND PROGRAM, 1992. To incur a bonded indebtedness of
\$350,000,000 to provide loans for the seismic strengthening of unreinforced masonry
buildings devoted to affordable housing and to market-rate residential, commercial and
7 institutional uses and to pay necessary administrative costs incidental thereto"; and

8 WHEREAS, such proposition was approved by two-thirds of the qualified electors of
9 the City voting on such proposition; and

WHEREAS, Proposition A allocated \$150,000,000 to make loans for affordable 10 housing buildings (the "Affordable Housing Loan Program") and \$200,000,000 to make loans 11 12 for market rate residential, commercial and institutional buildings (the "Market Rate Loan 13 Program" and together with the Affordable Housing Loan Program, the "Programs"); and WHEREAS, to date, the City has issued \$45,315,450 in loans to private parties under 14 15 the Affordable Housing Loan Program and \$44,000,000 in loans to private parties under the 16 Market Rate Loan Program, leaving \$260,684,550 of authorized but unissued bonding 17 authority under the Programs; and

18 WHEREAS, By Resolution No. 311-16, adopted by the Board of Supervisors (the "Board of Supervisors") of the City and County of San Francisco (the "City") on July 19, 2016, 19 20 it was determined and declared that it was in the public interest to access the remaining 21 bonding authority under the Programs and expand the permitted uses for which funds could 22 be loaned to finance the costs to acquire, improve and rehabilitate and to convert at-risk multi-23 unit residential buildings to permanent affordable housing by amending Proposition A; and, WHEREAS, By Ordinance No. 136-16, adopted by the Board of Supervisors on July 24 26, 2016 (the "2016 Bond Ordinance"), the Board of Supervisors duly called a special election 25

to be held on November 8, 2016, for the purpose of submitting to the electors of the City a
proposition to amend Proposition A to authorize the City to incur general obligation
indebtedness for the purposes of providing loans to finance the costs to acquire, improve and
rehabilitate and convert at-risk multi-unit residential buildings to permanent affordable
housing, performing needed seismic, fire, health and safety upgrades and other major
rehabilitation for habitability, and related costs necessary or convenient for the foregoing
purposes; and

8 WHEREAS, A special election was held in the City on November 8, 2016 (the
9 "Proposition C Bond Election"), for the purpose of submitting to the qualified voters of the City
10 said proposition, denominated as Proposition C ("Proposition C"), as follows:

- 11 "SAN FRANCISCO EARTHQUAKE LOAN AND HOUSING PRESERVATION BONDS,
- 1992. To amend 1992 voter approved measure Proposition A, to allow as an additional
   purpose the incurrence of bonded indebtedness to finance the acquisition,
- 14 improvement, and rehabilitation of at-risk multi-unit residential buildings and to convert
- 15 such structures to permanent affordable housing; shall the City and County of San
- 16 Francisco issue up to \$260,700,000 in general obligation bonds, subject to
- 17 independent citizen oversight and regular audits?"; and
- WHEREAS, By Resolution No. 34-19 (the "Authorizing Resolution"), adopted by the
  Board of Supervisors on January 29, 2019, the City authorized the issuance of the City and
- 20 County of San Francisco Taxable General Obligation Bonds (Social Bonds Affordable
- Housing, 2016) (the "Bonds"); and
- WHEREAS, It is necessary and desirable to issue one or more series of the Bonds on a taxable basis in an aggregate principal amount not to exceed \$75,000,000 (the "Series 24 2019A Bonds"), to provide funds to make loans the proceeds of which will finance a portion of
- the costs of projects for the additional purposes authorized by Proposition C; and

WHEREAS, The Series 2019A Bonds are being issued pursuant to the Authorizing
 Resolution and Title 5, Division 2, Part 1, Chapter 3, Article 4.5 of the California Government
 Code, the Charter of the City (the "Charter"), the 2016 Bond Ordinance and the Proposition C
 Bond Election;

5 WHEREAS, In accordance with Government Code Section 5852.1, the Board has 6 obtained and disclosed the information required thereby, as more fully set forth in the staff 7 report prepared by the Controller's Office of Public Finance ("Staff Report"); and

8 WHEREAS, Pursuant to the applicable provisions of the San Francisco Administrative 9 Code Sections 5.30-5.36, the Citizens' General Obligation Bond Oversight Committee shall conduct an annual review of bond spending and shall provide an annual report on the 10 management of the program to the Mayor and the Board of Supervisors, and, to the extent 11 12 permitted by law, one-tenth of one percent (0.1%) of the gross proceeds of the Series 2019A 13 Bonds shall be deposited in a fund established by the Office of the City Controller (the 14 "Controller") and appropriated by the Board of Supervisors at the direction of the Citizens' 15 General Obligation Bond Oversight Committee to cover the costs of such Committee and its 16 review process; now, therefore, be it

17 RESOLVED by the Board of Supervisors of the City and County of San Francisco, as18 follows:

Section 1. <u>Recitals</u>. All of the recitals in this Resolution are true and correct.
 Section 2. <u>Conditions Precedent</u>. All conditions, things and acts required by law to
 exist, to happen and to be performed precedent to and in connection with the issuance of the
 Series 2019A Bonds exist, have happened and have been performed in due time, form and
 manner in accordance with applicable law, and the City is now authorized pursuant to the
 Proposition C Bond Election, the Charter and applicable law to incur indebtedness in the
 manner and form provided in this Resolution.

Section 3. <u>Documents</u>. The documents presented to the Board of Supervisors and on
 file with the Clerk of the Board of Supervisors or designee thereof (the "Clerk of the Board of
 Supervisors") are contained in File No. 181219.

Section 4. Issuance and Sale of Series 2019A Bonds; Determination of Certain Terms; 4 5 Designation. The Board of Supervisors authorizes the issuance and sale of not to exceed 6 \$75,000,000 in aggregate principal amount of Bonds to be designated as "City and County of 7 San Francisco Taxable General Obligation Bonds (Social Bonds - Affordable Housing, 2016), 8 Series 2019A," for the purposes set forth in the 2016 Bond Ordinance and Proposition A, 9 approved by the voters at the Proposition A Bond Election, as amended by Proposition C, approved by the voters at the Proposition C Bond Election. Prior to issuance, the Series 10 2019A Bonds may be subdivided into more than one series. For purposes of this Resolution, 11 12 all of such subdivided series in the aggregate are referred to herein as the "Series 2019A 13 Bonds."

14 The Director of Public Finance or a designee thereof is authorized to determine, for the 15 Series 2019A Bonds, the sale date, the interest rates, the definitive principal amounts, the 16 maturity dates and the redemption dates, if any, and the terms of any optional or mandatory 17 redemption, subject to the other specific provisions of this Resolution, including the following 18 terms and conditions: (i) the Series 2019A Bonds shall not have a true interest cost in excess 19 of 12%; and (ii) the Series 2019A Bonds shall not have a final maturity date more than 40 20 years from their date of issuance. The Director of Public Finance is further authorized to give 21 the Series 2019A Bonds, including each subdivided series thereof, such additional or other 22 series designation, or to modify such series designation, as may be necessary or appropriate 23 to distinguish the Series 2019A Bonds from every other series of Bonds and from other bonds issued by the City, and otherwise as permitted by the Authorizing Resolution. 24

Section 5. Authentication and Registration of the Series 2019A Bonds. Each of the 1 2 Series 2019A Bonds shall be in fully registered form without coupons in denominations of 3 \$5,000 or any integral multiple of that amount. The officers of the City are directed to cause the Series 2019A Bonds to be prepared in sufficient quantity for delivery to or for the account 4 of their purchaser and the Director of Public Finance is directed to cause the blanks in the 5 6 Series 2019A Bonds to be completed in accordance with the Authorizing Resolution, the 7 Official Statement, and the Bond Award or Bond Purchase Contract (as defined below), as 8 applicable, to procure their execution by the proper officers of the City (including by facsimile 9 signature if necessary or convenient, except that any signature of the Clerk of the Board of Supervisors shall be by manual signature) and authentication as provided in this Section, and 10 to deliver the Series 2019A Bonds when so executed and authenticated to said purchaser in 11 12 exchange for their purchase price, all in accordance with the Authorizing Resolution.

13 The Series 2019A Bonds and the certificate of authentication and registration, to be 14 manually executed by the Treasurer of the City or designee thereof (the "City Treasurer"), and the form of assignment to appear on the Series 2019A Bonds shall be substantially in the 15 16 form attached as Exhibit A (a copy of which is on file with the Clerk of the Board of 17 Supervisors and which is declared to be a part of this Resolution as if fully set forth in this 18 Resolution), with necessary or appropriate variations, omissions and insertions as permitted or required by this Resolution, the Official Statement and the Bond Award or the Bond 19 20 Purchase Contract, as applicable.

21 Only Series 2019A Bonds bearing a certificate of authentication and registration 22 executed by the City Treasurer shall be valid or obligatory for any purpose or entitled to the 23 benefits of the Authorizing Resolution and this Resolution, and such certificate of the City 24 Treasurer, executed as provided in this Resolution, shall be conclusive evidence that the 25 Series 2019A Bonds so authenticated have been duly authenticated and delivered under, and 1

are entitled to the benefits of, the Authorizing Resolution and this Resolution.

The Controller shall assign a distinctive letter, or number, or letter and number to each
Series 2019A Bond authenticated and registered by the City Treasurer and shall maintain a
record thereof which shall be available for inspection.

5 Section 6. Registration Books. The City Treasurer shall keep or cause to be kept, at 6 the office of the City Treasurer or at the designated office of any registrar appointed by the 7 City Treasurer, separate and sufficient books for the registration and transfer of Series 2019A 8 Bonds, which books shall at all times be open to inspection, and upon presentation for such 9 purpose, the City Treasurer shall, under such reasonable regulations as he or she may prescribe, register or transfer or cause to be registered or transferred, on said books, Series 10 2019A Bonds as provided in this Resolution. The City and the City Treasurer may treat the 11 12 registered owner of each Series 2019A Bond as its absolute owner for all purposes, and the 13 City and the City Treasurer shall not be affected by any notice to the contrary.

14 Section 7. <u>Transfer or Exchange of Series 2019A Bonds</u>. Any Series 2019A Bond 15 may, in accordance with its terms, be transferred upon the books required to be kept pursuant 16 to the provisions of Section 6, by the person in whose name it is registered, in person or by 17 the duly authorized attorney of such person in writing, upon surrender of such Series 2019A 18 Bond for cancellation, accompanied by delivery of a duly executed written instrument of

19 transfer in a form approved by the City Treasurer.

Any Series 2019A Bond may be exchanged at the office of the City Treasurer for a like aggregate principal amount of other authorized denominations of the same interest rate and maturity.

Whenever any Series 2019A Bond shall be surrendered for transfer or exchange, the designated City officials shall execute (as provided in Section 5) and the City Treasurer shall authenticate and deliver a new Series 2019A Bond of the same interest rate and maturity in a like aggregate principal amount. The City Treasurer shall require the payment by any bond
 owner requesting any such transfer of any tax or other governmental charge required to be
 paid with respect to such transfer or exchange.

No transfer or exchange of Series of 2019A Bonds shall be required to be made by the
City Treasurer during the period from the Record Date (as defined in Section 8(b)) next
preceding each interest payment date to such interest payment date or after a notice of
redemption shall have been mailed with respect to such Series 2019A Bonds.

Section 8. Terms of the Series 2019A Bonds; General Redemption Provisions.

9 (a) <u>Date of the Series 2019A Bonds</u>. The Series 2019A Bonds shall be dated the
10 date of their delivery or such other date (the "Dated Date") as is specified in the Bond Award
11 or the Bond Purchase Contract.

(b) <u>Payment of the Series 2019A Bonds</u>. The principal of the Series 2019A Bonds
shall be payable in lawful money of the United States of America to their owners, upon
surrender at maturity or earlier redemption at the office of the City Treasurer. The interest on
the Series 2019A Bonds shall be payable in like lawful money to the person whose name
appears on the bond registration books of the City Treasurer as the owner as of the close of
business on the last day of the month immediately preceding an interest payment date (the
"Record Date"), whether or not such day is a Business Day (as defined below).

Except as may be otherwise provided in connection with any book-entry only system applicable to the Series 2019A Bonds, payment of the interest on any Series 2019A Bond shall be made by check mailed on the interest payment date to such owner at such owner's address as it appears on the registration books as of the Record Date; provided, that if any interest payment date occurs on a day that banks in California or New York are closed for business or the New York Stock Exchange is closed for business, then such payment shall be made on the next succeeding day that banks in both California and New York are open for business and the New York Stock Exchange is open for business (each, a "Business Day");
and provided, further, that the registered owner of an aggregate principal amount of at least
\$1,000,000 of Series 2019A Bonds may submit a written request to the City Treasurer on or
before a Record Date preceding an interest payment date for payment of interest on the next
succeeding interest payment date and thereafter by wire transfer to a commercial bank
located within the United States of America.

For so long as any Series 2019A Bonds are held in book-entry form by a securities
depository selected by the City pursuant to Section 11, payment shall be made to the
registered owner of the Series 2019A Bonds designated by such securities depository by wire
transfer of immediately available funds.

Interest on the Series 2019A Bonds. The Series 2019A Bonds shall bear 11 (c) 12 interest at rates to be determined upon the sale of the Series 2019A Bonds, calculated on the 13 basis of a 360-day year comprised of twelve 30-day months, payable on June 15, 2019 (or 14 such other date as may be designated in the Bond Award or the Bond Purchase Contract), 15 and semiannually thereafter on June 15 and December 15 of each year. Each Series 2019A 16 Bond shall bear interest from the interest payment date next preceding the date of its 17 authentication unless it is authenticated as of a day during the period from the Record Date 18 next preceding any interest payment date to the interest payment date, inclusive, in which 19 event it shall bear interest from such interest payment date, or unless it is authenticated on or 20 before the first Record Date, in which event it shall bear interest from the Dated Date; 21 provided, that if, at the time of authentication of any Series 2019A Bond, interest is in default on the Series 2019A Bonds, such Series 2019A Bond shall bear interest from the interest 22 23 payment date to which interest has previously been paid or made available for payment on the Series 2019A Bonds or from the Dated Date if the first interest payment is not made. 24 /// 25

(d) <u>Optional Redemption</u>. The Series 2019A Bonds shall be subject to optional
 redemption prior to maturity as shall be provided in the Official Statement.

(e) <u>Mandatory Redemption</u>. The Series 2019A Bonds shall be subject to mandatory redemption as provided in the final Official Statement (as defined hereinbelow).

The principal of and interest on the Series 2019A Bonds subject to mandatory 5 6 redemption shall be paid from the Series 2019A Bond Subaccount established in Section 9, 7 pursuant to Section 9. In lieu of any such mandatory redemption for Series 2019A Bonds, at 8 any time prior to the selection of Series 2019A Bonds for mandatory redemption, the City may 9 apply amounts on deposit in the Series 2019A Bond Subaccount to make such payment to the purchase, at public or private sale, of Series 2019A Bonds subject to such mandatory 10 redemption, and when and at such prices not in excess of the principal amount thereof 11 12 (including sales commission and other charges but excluding accrued interest), as the City 13 may determine.

(f) <u>Selection of Series 2019A Bonds for Redemption</u>. Whenever less than all of the
 outstanding Series 2019A Bonds are called for redemption, the manner of selection of the
 portion of such Series 2019A Bonds called for redemption shall be as specified in the Official
 Statement for the Series 2019A Bonds.

18 (g) Notice of Redemption. The date on which Series 2019A Bonds that are called 19 for redemption are to be presented for redemption is called the "Redemption Date." The City 20 Treasurer shall mail, or cause to be mailed, notice of any redemption of Series 2019A Bonds, 21 postage prepaid, to the respective registered owners at the addresses appearing on the bond 22 registration books not less than twenty (20) nor more than sixty (60) days prior to the 23 Redemption Date. The notice of redemption shall (a) state the Redemption Date; (b) state the redemption price; (c) state the maturity dates of the Series 2019A Bonds to be redeemed and, 24 if less than all of any such maturity is called for redemption, the distinctive numbers of the 25

1 Series 2019A Bonds of such maturity to be redeemed, and in the case of any Series 2019A 2 Bonds to be redeemed in part only, the respective portions of the principal amount to be 3 redeemed; (d) state the CUSIP number, if any, of each Series 2019A Bond to be redeemed; (e) require that such Series 2019A Bonds be surrendered by the owners at the office of the 4 5 City Treasurer or his or her agent; and (f) give notice that interest on such Series 2019A Bond 6 or portion of Series 2019A Bond to be redeemed will cease to accrue after the Redemption 7 Date. Notice of optional redemption may be conditional upon receipt of funds or other event 8 specified in the notice of redemption as provided in subsection (j) of this Section 8.

9 The actual receipt by the owner of any Series 2019A Bond of notice of such 10 redemption shall not be a condition precedent to redemption, and failure to receive such 11 notice, or any defect in such notice so mailed, shall not affect the validity of the proceedings 12 for the redemption of such Series 2019A Bonds or the cessation of accrual of interest on such 13 Series 2019A Bonds on the Redemption Date.

14 Notice of redemption also shall be given, or caused to be given by the City Treasurer, by (i) registered or certified mail, postage prepaid, (ii) confirmed facsimile transmission, (iii) 15 16 overnight delivery service, or (iv) to the extent acceptable to the intended recipient, email or 17 similar electronic means, to (a) all organizations registered with the Securities and Exchange 18 Commission as securities depositories and (b) such other services or organizations as may 19 be required in accordance with the Continuing Disclosure Certificate described in Section 19. 20 The notice or notices required for redemption shall be given by the City Treasurer or 21 any agent appointed by the City. A certificate of the City Treasurer or such other appointed 22 agent of the City that notice of redemption has been given to the owner of any Series 2019A 23 Bond to be redeemed in accordance with this Resolution shall be conclusive against all parties. 24

1 (h) Series 2019A Redemption Account. At the time the Director of Public Finance 2 determines to optionally call and redeem any of the Series 2019A Bonds, the Controller or his 3 or her agent shall establish a redemption account to be described or known as the " General Obligation Bonds, Taxable Series 2019A Redemption Account" (the "Series 2019A 4 5 Redemption Account"), and prior to or on the Redemption Date there must be set aside in the 6 Series 2019A Redemption Account moneys available for the purpose and sufficient to 7 redeem, as provided in this Resolution, the Series 2019A Bonds designated in said notice of 8 redemption, subject to the provisions of subsection (j) of this Section. Said moneys must be 9 set aside in the Series 2019A Redemption Account solely for the purpose of, and shall be applied on or after the Redemption Date to, payment of the redemption price of the Series 10 2019A Bonds to be redeemed upon presentation and surrender of such Series 2019A Bonds. 11 12 Any interest due on or prior to the Redemption Date may be paid from the Series 2019A Bond 13 Subaccount as provided in Section 9 or from the Series 2019A Redemption Account. Moneys 14 held from time to time in the Series 2019A Redemption Account shall be invested by the City 15 Treasurer pursuant to the City's policies and guidelines for investment of moneys in the 16 General Fund of the City. If, after all of the Series 2019A Bonds have been redeemed and 17 canceled or paid and canceled, there are moneys remaining in the Series 2019A Redemption 18 Account, said moneys shall be transferred to the General Fund of the City or to such other 19 fund or account as required by applicable law; provided, that if said moneys are part of the 20 proceeds of refunding bonds, said moneys shall be transferred pursuant to the resolution 21 authorizing such refunding bonds.

(i) <u>Effect of Redemption</u>. When notice of optional redemption has been given
 substantially as provided in this Resolution, and when the amount necessary for the
 redemption of the Series 2019A Bonds called for redemption (principal, premium, if any, and
 accrued interest to such Redemption Date) is set aside for that purpose in the Series 2019A

1 Redemption Account or the Series 2019A Bond Subaccount, the Series 2019A Bonds 2 designated for redemption shall become due and payable on the Redemption Date, and upon 3 presentation and surrender of said Series 2019A Bonds at the place specified in the notice of 4 redemption, such Series 2019A Bonds shall be redeemed and paid at said redemption price 5 out of said Series 2019A Redemption Account. No interest will accrue on such Series 2019A 6 Bonds called for redemption after the Redemption Date and the registered owners of such 7 Series 2019A Bonds shall look for payment of such Series 2019A Bonds only to the Series 8 2019A Redemption Account. All Series 2019A Bonds redeemed shall be canceled 9 immediately by the City Treasurer and shall not be reissued.

(j) Conditional Notice of Redemption; Rescission of Redemption. Any notice of 10 optional redemption given as provided in Section 8(g) may provide that such redemption is 11 12 conditioned upon: (i) deposit in the Series 2019A Redemption Account of sufficient moneys to 13 redeem the Series 2019A Bonds called for optional redemption on the anticipated 14 Redemption Date, or (ii) the occurrence of any other event specified in the notice of 15 redemption. If conditional notice of redemption has been given substantially as provided in 16 this subsection (j), and on the scheduled Redemption Date (i) sufficient moneys to redeem the 17 Series 2019A Bonds called for optional redemption on the Redemption Date have not been 18 deposited in the Series 2019A Redemption Account, or (ii) any other event specified in the 19 notice of redemption as a condition to the redemption has not occurred, then (y) the Series 20 2019A Bonds for which conditional notice of redemption was given shall not be redeemed on 21 the anticipated Redemption Date and shall remain Outstanding for all purposes of this Resolution, and (z) the redemption not occurring shall not constitute a default under this 22 23 Resolution or the Authorizing Resolution. The City may rescind any optional redemption and notice of it for any reason on any 24

25 date prior to any Redemption Date by causing written notice of the rescission to be given to

the owners of all Series 2019A Bonds so called for redemption. Notice of any such rescission
of redemption shall be given in the same manner notice of redemption was originally given.
The actual receipt by the owner of any Series 2019A Bond of notice of such rescission shall
not be a condition precedent to rescission, and failure to receive such notice or any defect in
such notice so mailed shall not affect the validity of the rescission.

6 Section 9. <u>Series 2019A Bond Subaccount</u>. There is established with the City 7 Treasurer a special subaccount in the General Obligations Bonds (Prop A, 1992/Prop C, 8 2016) Bond Account (the "Bond Account") created pursuant to the Authorizing Resolution to 9 be designated as the "Taxable General Obligation Bonds, Series 2019A Bond Subaccount" 10 (the "Series 2019A Bond Subaccount"), to be held separate and apart from all other accounts 11 of the City. All interest earned on amounts on deposit in the Series 2019A Bond Subaccount 12 shall be retained in the Series 2019A Bond Subaccount.

Amounts deposited in the Series 2019A Bond Subaccount pursuant to clause (a) of Section 17 hereof, representing capitalized interest on the Bonds, shall be used to make interest payments on the Bonds through and including December 15, 2019, or such other date as may be provided in the Official Statement.

17 On or prior to the date on which any payment of principal of or interest on the Series 18 2019A Bonds is due, including any Series 2019A Bonds subject to mandatory redemption on 19 said date, the City Treasurer shall allocate to and deposit in the Series 2019A Bond 20 Subaccount, first from amounts held in the Program Revenues Subaccount of the Bond 21 Account, until such subaccount is exhausted, and second, from amounts held in the Tax 22 Revenues Subaccount of the Bond Account, an aggregate amount which, when added to any 23 available moneys contained in the Series 2019A Bond Subaccount, is sufficient to pay principal of and interest on the Series 2019A Bonds on such date. 24

25 ///

On or prior to the date on which any Series 2019A Bonds are to be redeemed at the 1 2 option of the City pursuant to this Resolution, the City Treasurer may allocate to and deposit 3 in the Series 2019A Redemption Account, from amounts held in the Bond Account pursuant to Section 8 of the Authorizing Resolution, an amount which, when added to any available 4 5 moneys contained in the Series 2019A Redemption Account, is sufficient to pay principal, 6 interest and premium, if any, with respect to such Series 2019A Bonds on such date. The 7 City Treasurer may make such other provision for the payment of principal of and interest and 8 any redemption premium on the Series 2019A Bonds as is necessary or convenient to permit 9 the optional redemption of the Series 2019A Bonds.

Amounts in the Series 2019A Bond Subaccount may be invested in any investment of the City in which moneys in the General Fund of the City are invested. The City Treasurer may (i) commingle any of the moneys held in the Series 2019A Bond Subaccount with other City moneys or (ii) deposit amounts credited to the Series 2019A Bond Subaccount into a separate fund or funds for investment purposes only; provided, that all of the moneys held in the Series 2019A Bond Subaccount shall be accounted for separately notwithstanding any such commingling or separate deposit by the City Treasurer.

Section 10. Series 2019A Project Subaccount. There is established with the City 17 18 Treasurer a special subaccount in the General Obligation Bonds (Prop A, 1992/Prop C, 2016) Project Account (the "Project Account") created pursuant to the Authorizing Resolution to be 19 20 designated the "Taxable General Obligation Bonds, Series 2019A Project Subaccount" (the 21 "Series 2019A Project Subaccount"), to be held separate and apart from all other accounts of the City. All interest earned on amounts on deposit in the Series 2019A Project Subaccount 22 23 shall be retained in the Series 2019A Project Subaccount. Amounts in the Series 2019A Project Subaccount shall be expended in accordance with the provisions of the Authorizing 24 25 Resolution for the acquisition, construction or reconstruction of the Project (as defined in the

1 Authorizing Resolution).

Amounts in the Series 2019A Project Subaccount may be invested in any investment of the City in which moneys in the General Fund of the City are invested. The City Treasurer may (i) commingle any of the moneys held in the Series 2019A Project Subaccount with other City moneys or (ii) deposit amounts credited to the Series 2019A Project Subaccount into a separate fund or funds for investment purposes only; provided, that all of the moneys held in the Series 2019A Project Subaccount (including interest earnings) shall be accounted for separately notwithstanding any such comingling or separate deposit by the City Treasurer.

9 The City Treasurer is authorized to pay or cause to be paid from the proceeds of the 10 Series 2019A Bonds, on behalf of the City, the costs of issuance associated with the Series 2019A Bonds. Costs of issuance of the Series 2019A Bonds shall include, without limitation, 12 bond and financial printing expenses, mailing and publication expenses, rating agency fees, 13 the fees and expenses of paying agents, registrars, financial consultants, disclosure counsel 14 and co-bond counsel, and the reimbursement of departmental expenses in connection with 15 the issuance of the Series 2019A Bonds.

16 Section 11. Appointment of Depositories and Other Agents. The City Treasurer is 17 authorized and directed to appoint one or more depositories as he or she may deem desirable 18 and the procedures set forth in Section 6, Section 7 and Section 8 relating to registration of 19 ownership of the Series 2019A Bonds and payments and redemption notices to owners of the 20 Series 2019A Bonds may be modified to comply with the policies and procedures of such 21 depository. The City will not have any responsibility or obligation to any purchaser of a 22 beneficial ownership interest in any Series 2019A Bonds or to any participants in such a 23 depository with respect to (i) the accuracy of any records maintained by such securities depository or any participant therein; (ii) any notice that is permitted or required to be given to 24 the owners of Series 2019A Bonds under this Resolution; (iii) the selection by such securities 25

depository or any participant therein of any person to receive payment in the event of a partial
redemption of Series 2019A Bonds; (iv) the payment by such securities depository or any
participant therein of any amount with respect to the principal or redemption premium, if any,
or interest due with respect to Series 2019A Bonds; (v) any consent given or other action
taken by such securities depository as the owner of Series 2019A Bonds; or (vi) any other
matter.

7 The Depository Trust Company ("DTC") is appointed as depository for the Series 8 2019A Bonds. The Series 2019A Bonds shall be initially issued in book-entry form. Upon 9 initial issuance, the ownership of each Series 2019A Bond shall be registered in the bond 10 register in the name of Cede & Co., as nominee of DTC. So long as each Series 2019A Bond 11 is registered in book-entry form, each Series 2019A Bond shall be registered in the name of 12 Cede & Co. or in the name of such successor nominee as may be designated from time to 13 time by DTC or any successor as depository.

14 The City Treasurer is also authorized and directed to appoint one or more agents as he 15 or she may deem necessary or desirable. To the extent permitted by applicable law and 16 under the supervision of the City Treasurer, such agents may serve as paying agent, fiscal 17 agent, rebate calculation agent, escrow agent or registrar for the Series 2019A Bonds or may 18 assist the City Treasurer in performing any or all of such functions and such other duties as 19 the City Treasurer shall determine. Such agents shall serve under such terms and conditions 20 as the City Treasurer shall determine. The City Treasurer may remove or replace agents 21 appointed pursuant to this paragraph at any time.

22 Section 12. <u>Defeasance Provisions</u>. Payment of all or any portion of the Series 2019A 23 Bonds may be provided for prior to such Series 2019A Bonds' respective stated maturities by 24 irrevocably depositing with the Treasurer (or any commercial bank or trust company 25 designated by the Treasurer to act as escrow agent with respect thereto), in a separate account not commingled with other moneys or securities held by the Treasurer or such
 escrow agent:

3 (a) An amount of cash equal to the principal amount of all of such Series 2019A Bonds or a portion thereof, and all unpaid interest thereon to maturity, except that in the case 4 5 of Series 2019A Bonds which are to be redeemed prior to such Series 2019A Bonds' 6 respective stated maturities and in respect of which notice of such redemption shall have 7 been given as provided in Section 8 hereof or an irrevocable election to give such notice shall 8 have been made by the City, the amount to be deposited shall be the principal amount 9 thereof, all unpaid interest thereon to the Redemption Date, and any premium due on such Redemption Date; or 10

11 (b) Defeasance Securities (as herein defined) not subject to call, except as provided 12 below in the definition thereof, maturing and paying interest at such times and in such 13 amounts; together with interest earnings and cash, if required, as will, without reinvestment, 14 as certified by an independent certified public accountant, be fully sufficient to pay the 15 principal and all unpaid interest to maturity, or to the Redemption Date, as the case may be, 16 and any premium due on the Series 2019A Bonds to be paid or redeemed, as such principal 17 and interest come due; provided, that, in the case of the Series 2019A Bonds which are to be 18 redeemed prior to maturity, notice of such redemption shall be given as provided in Section 8 19 hereof or an irrevocable election to give such notice shall have been made by the City; then, 20 all obligations of the City with respect to said outstanding Series 2019A Bonds shall cease 21 and terminate, except only the obligation of the City to pay or cause to be paid from the funds 22 deposited pursuant to paragraphs (a) or (b) of this Section 12, to the owners of said Series 23 2019A Bonds all sums due with respect thereto; and provided further, that the City shall have received an opinion of nationally recognized bond counsel, that provision for the payment of 24 25 said Series 2019A Bonds has been made in accordance with this Section 12.

For purposes of this Section 12, "Defeasance Securities" shall mean any of the
 following that at the time are legal investments under the laws of the State of California for the
 moneys proposed to be invested:

4

(1) United States Obligations (as defined below); and

5 (2) Pre-refunded fixed interest rate municipal obligations meeting the following 6 conditions: (a) the municipal obligations are not subject to redemption prior to maturity, or the 7 trustee or paying agent has been given irrevocable instructions concerning their calling and 8 redemption and the issuer has covenanted not to redeem such obligations other than as set 9 forth in such instructions; (b) the municipal obligations are secured by cash and/or United States Obligations; (c) the principal of and interest on the United States Obligations (plus any 10 11 cash in the escrow fund or the redemption account) are sufficient to meet the liabilities of the 12 municipal obligations; (d) the United States Obligations serving as security for the municipal 13 obligations are held by an escrow agent or trustee; (e) the United States Obligations are not 14 available to satisfy any other claims, including those against the trustee or escrow agent; and (f) the municipal obligations are rated (without regard to any numerical modifier, plus or minus 15 16 sign or other modifier), at the time of original deposit to the escrow fund, by any two Rating 17 Agencies (as defined below) not lower than the rating then maintained by such Rating 18 Agencies on such United States Obligations

For purposes of this Section 12, "United States Obligations" means (i) direct and general obligations of the United States of America, or obligations that are unconditionally guaranteed as to principal and interest by the United States of America, including without limitation, the interest component of Resolution Funding Corporation (REFCORP) bonds that have been stripped by request to the Federal Reserve Bank of New York in book-entry form or (ii) any security issued by an agency or instrumentality of the United States of America that is selected by the Director of Public Finance that results in the escrow fund being rated by any two Rating Agencies, at the time of the initial deposit to the escrow fund and upon any
 substitution or subsequent deposit to the escrow fund, not lower than the rating then
 maintained by the respective Rating Agency on United States Obligations described in clause
 (i) above.

For purposes of this Section 12, "Rating Agencies" means Moody's Investors Service,
Inc., Fitch Ratings, and S&P Global Ratings, or any other nationally recognized bond rating
agency that is the successor to any of the foregoing rating agencies or that is otherwise
established after the date hereof.

9 Section 13. <u>Sale of Series 2019A Bonds by Competitive or Negotiated Sale</u>. The
10 Board of Supervisors authorizes the sale of the Series 2019A Bonds by solicitation of
11 competitive bids or by negotiated sale to one or more underwriters to be appointed in
12 accordance with City policies, as so determined by the Director of Public Finance pursuant to
13 Section 16.

14

## Section 14. Official Notice of Sale; Receipt of Bids; Bond Award.

Official Notice of Sale. The form of proposed Official Notice of Sale ("Official 15 (a) Notice of Sale") inviting bids for the Series 2019A Bonds submitted to the Board of 16 17 Supervisors is approved and adopted as the Official Notice of Sale inviting bids for the Series 18 2019A Bonds, with such changes, additions and modifications as may be made in accordance with Section 20. The Director of Public Finance is authorized and directed to cause to be 19 20 mailed or otherwise circulated to prospective bidders for the Series 2019A Bonds copies of 21 the Official Notice of Sale, subject to such corrections, revisions or additions as may be acceptable to the Director of Public Finance. 22

(b) <u>Receipt of Bids</u>. Bids shall be received on the date designated by the Director
 of Public Finance pursuant to Section 4.

25 ///

(c) Bond Award. As provided in the Official Notice of Sale, the City may reject any 1 2 and all bids received for any reason. The Controller is authorized to award the Series 2019A 3 Bonds to the responsible bidder whose bid (a) is timely received and conforms to the Official Notice of Sale, except to the extent informalities and irregularities are waived by the City as 4 5 permitted by the Official Notice of Sale, and (b) represents the lowest true interest cost to the 6 City in accordance with the procedures described in the Official Notice of Sale. The award, if 7 made, shall be set forth in a certificate signed by the Controller setting forth the terms of the 8 Series 2019A Bonds and the original purchasers (the "Bond Award"). The Controller shall 9 provide a copy of the Bond Award as soon as practicable to the Clerk of the Board of Supervisors and the Director of Public Finance; provided, that failure to provide such copy 10 shall not affect the validity of the Bond Award. 11

12 Section 15. <u>Publication of Notice of Intention to Sell Bonds</u>. The form of proposed 13 Notice of Intention to Sell the Series 2019A Bonds (the "Notice of Intention to Sell Bonds") 14 submitted to the Board of Supervisors is approved and adopted as the Notice of Intention to 15 Sell the Series 2019A Bonds, and the Director of Public Finance is authorized and directed to 16 cause the Notice of Intention to Sell Bonds, subject to such corrections, revisions or additions 17 as may be made in accordance with Section 20, to be published once in *The Bond Buyer* or 18 another financial publication generally circulated throughout the State of California.

Section 16. <u>Authorization of Negotiated Sale; Authorization to Select Underwriters;</u>
Form of Bond Purchase Contract Approval. The Controller, in consultation with the Director of
Public Finance, is hereby authorized to conduct the sale of the Series 2019A Bonds by
negotiated sale pursuant to one or more Bond Purchase Contracts (each, a "Bond Purchase
Contract"), each by and between the City and the underwriter(s) named therein (the
"Underwriters"), if the Controller determines that such manner of sale is in the best financial
interest of the City, such determination to be conclusively evidenced by the execution and

1 delivery of such Bond Purchase Contract as hereinafter approved. The form of such Bond 2 Purchase Contract as presented to this Board of Supervisors, a copy of which is on file with 3 the Clerk of the Board, is hereby approved. The Controller or the Director of Public Finance is hereby authorized to execute such Bond Purchase Contract with such changes, additions and 4 modifications as the Controller or the Director of Public Finance may make or approve in 5 6 accordance with Section 20 hereof; provided however, that the Underwriters' discount under 7 any such Bond Purchase Contract shall not exceed 2.00% of the principal amount of the 8 Series 2019A Bonds.

In order to facilitate the sale of the Series 2019A Bonds by negotiated sale, the
Controller or the Director of Public Finance is hereby authorized and directed to appoint one
or more financial institutions to act as underwriter for the Series 2019A Bonds in accordance
with City policies and procedures, including, but not limited to, the City's policy to provide
locally disadvantaged minority business enterprises and women enterprises an equal
opportunity to participate in the performance of all City contracts.

For purposes of California Government Code Section 53508.9, the Board hereby finds 15 16 the following to be true and correct: (1) a negotiated sale of the Series 2019A Bonds would be 17 in the best financial interest of the City because the City will be able to obtain market and 18 structuring advice from the underwriters and flexibility as to timing of sale and ability to 19 premarket bonds; (2) the co-bond counsel to the City with respect to the Series 2019A Bonds 20 shall be Jones Hall, A Professional Law Corporation, and Amira Jackmon, Attorney at Law; 21 (3) the underwriters with respect to a negotiated sale of the Series 2019A Bonds shall be 22 Citigroup Global Markets Inc., Raymond James & Associates and Loop Capital Markets; (4) 23 the co-financial advisors with respect to the Series 2019A Bonds shall be Sperry Capital Inc. and Ross Financial; and (5) the estimated costs of issuance of the Bonds shall be as set forth 24 in the Staff Report. 25

Section 17. Disposition of Proceeds of Sale. The proceeds of sale of the Series 1 2 2019A Bonds shall be applied by the City Treasurer as follows: (a) accrued interest, if any, 3 shall be deposited into the Series 2019A Bond Subaccount; (b) premium, if any, shall be deposited into the Series 2019A Bond Subaccount; (c) amounts required to pay interest on 4 the Series 2019A Bonds through and including December 15, 2019 (or such other date as 5 6 may be set forth in the Official Statement), shall be deposited into the Series 2019A Bond 7 Subaccount, and (d) remaining proceeds of sale shall be deposited into the Series 2019A 8 Project Subaccount.

9 Section 18. Official Statement. The form of proposed Preliminary Official Statement describing the Series 2019A Bonds (the "Preliminary Official Statement") submitted to the 10 Board of Supervisors is approved and adopted as the Preliminary Official Statement 11 12 describing the Series 2019A Bonds, with such additions, corrections and revisions as may be 13 determined to be necessary or desirable made in accordance with Section 20. The Controller 14 is authorized to cause the distribution of a Preliminary Official Statement deemed final for 15 purposes of Securities and Exchange Commission Rule 15c2-12 promulgated under the Securities Exchange Act of 1934, as amended (the "Rule"), and to sign a certificate to that 16 17 effect. The Director of Public Finance is authorized and directed to cause to be printed and 18 mailed or electronically distributed to prospective bidders for the Series 2019A Bonds the 19 Preliminary Official Statement in substantially the form of the Preliminary Official Statement 20 approved and adopted by this Resolution, as completed, supplemented, corrected or revised. 21 The Controller is authorized and directed to approve, execute, and deliver the final Official Statement with respect to the Series 2019A Bonds (the "Official Statement"), which final 22 23 Official Statement shall be in the form of the Preliminary Official Statement, with such additions, corrections and revisions as may be determined to be necessary or desirable made 24 in accordance with Section 20 and as are permitted under the Rule. The Director of Public 25

Finance is authorized and directed to cause to be printed and mailed or electronically
 distributed the final Official Statement to all actual initial purchasers of the Series 2019A
 Bonds.

Section 19. Continuing Disclosure Certificate. The form of Continuing Disclosure 4 5 Certificate (the "Continuing Disclosure Certificate"), to be signed by the City to permit the 6 original purchasers of the Series 2019A Bonds to comply with the Rule, submitted to the 7 Board of Supervisors is approved and adopted as the Continuing Disclosure Certificate, with 8 such additions, corrections and revisions as may be determined to be necessary or desirable 9 made in accordance with Section 20. The Controller is authorized and directed to execute the Continuing Disclosure Certificate on behalf of the City and deliver the Continuing Disclosure 10 11 Certificate to the original purchasers of the Series 2019A Bonds.

12 Section 20. Modification to Documents. Any City official authorized by this Resolution 13 to execute any document is further authorized, in consultation with the City Attorney and co-14 bond counsel, to approve and make such changes, additions, amendments or modifications 15 to the document or documents such official is authorized to execute as may be necessary or 16 advisable (provided, that such changes, additions, amendments or modifications shall not 17 authorize an aggregate principal amount of Series 2019A Bonds in excess of \$75,000,000 or 18 conflict with the provisions of Section 4). The approval of any change, addition, amendment or modification to any of the aforementioned documents shall be evidenced conclusively by 19 20 the execution and delivery of the document in question.

21 Section 21. <u>Ratification</u>. All actions previously taken by officials, employees and 22 agents of the City with respect to the sale and issuance of the Series 2019A Bonds,

consistent with any documents presented and this Resolution, are approved, confirmed andratified.

25 ///

Section 22. <u>Relationship to Authorizing Resolution</u>. In the event of any conflict
 between this Resolution and the Authorizing Resolution, the terms of this Resolution shall
 control. Without limiting the foregoing and notwithstanding the provisions of the Authorizing
 Resolution, the City is not obligated to transfer money from the General Fund of the City to
 the Bond Account to pay the principal of or interest on the Series 2019A Bonds.

6 Section 23. <u>Accountability Reports</u>. The Series 2019A Bonds are subject to 7 accountability requirements under the City's Administrative Code and the 2016 Bond 8 Ordinance. The deadline for submission of the Accountability report(s) under Administrative 9 Code Sections 2.71(a) and 2.71(b) are hereby waived with respect to the Series 2019A 10 Bonds. Accountability report(s) with respect to the Series 2019A Bonds shall be submitted in 11 all other respects in the manner required by the Administrative Code and the 2016 Bond 12 Ordinance.

Section 24. <u>Citizens' Oversight Committee</u>. The Series 2019A Bonds are subject to, and incorporate by reference, the applicable provisions of the San Francisco Administrative Code Sections 5.30-5.36 (the "Citizens' General Obligation Bond Oversight Committee"), and, to the extent permitted by law, one tenth of one percent (0.1%) of the gross proceeds of the Series 2019A Bonds shall be deposited into a fund established by the Controller's Office and appropriated by the Board of Supervisors at the direction of the Citizens' General Obligation Bond Oversight Committee to cover the costs of such committee.

20 Section 25. <u>CEQA Determination</u>. The Board of Supervisors hereby reaffirms and 21 incorporates by reference the CEQA findings and determinations set forth in the 2016 Bond 22 Ordinance as if set forth in full herein. The use of bond proceeds to finance any project or 23 portion of any project with Bond proceeds will be subject, as necessary, to approval of the 24 Board of Supervisors upon completion of any planning and any further required environmental 25 review under CEQA for the individual facilities and projects.

1	Section 26. General Authority. The Clerk of the Board of Supervisors, the Mayor, the		
2	City Treasurer, the Director of Public Finance, the City Attorney and the Controller are each		
3	authorized and directed in the name and on behalf of the City to take any and all steps and to		
4	issue, deliver or enter into any and all certificates, requisitions, agreements, notices,		
5	consents, and other documents as may be necessary to give effect to the provisions of this		
6	Resolution, including but not limited to letters of representations to any depository or		
7	depositories, which they or any of them might deem necessary or appropriate in order to		
8	consummate the lawful issuance, sale and delivery of the Series 2019A Bonds. Any such		
9	actions are solely intended to further the purposes of this Resolution, and are subject in all		
10	respects to the terms of this Resolution. No such actions shall increase the risk to the City or		
11	require the City to spend any resources not otherwise granted herein. Final versions of any		
12	such documents shall be provided to the Clerk of the Board of Supervisors for inclusion in the		
13	official file within 30 days (or as soon thereafter as final documents are available) of execution		
14	by all parties.

The interest on this bond is payable 13 to the person whose name appears on the bond registration books of the City Treasurer as the Registered Owner of this bond as of the close of business on the Record Date 14 15 immediately preceding an interest payment date, whether or not such day is a Business Day, 16 such interest to be paid by check mailed on the interest payment date to such Registered 17 Owner at the owner's address as it appears on such registration books; provided, that the 18 Registered Owner of bonds in an aggregate principal amount of at least \$1,000,000 may submit a written request to the City Treasurer on or before the Record Date preceding any 19 20 interest payment date for payment of interest by wire transfer to a commercial bank located in 21 the United States of America.

This bond is one of a duly authorized issue of bonds (the "**Bonds**") of like tenor (except for such variations, if any, as may be required to designate varying numbers, denominations, interest rates and maturities), in the aggregate principal amount of \$\_\_\_\_\_, which is part of a bond authorization in the aggregate original principal amount of \$260,684,550 The Bonds are issuable as fully registered bonds without coupons in the
denominations of \$5,000 or any integral multiple of such amount, *provided* that no bond shall

Official notices of redemption will contain the information specified in the Resolutions.

23 On or prior to any Redemption Date, the City is required to deposit an amount of 24 money sufficient to pay the redemption price of all of the Bonds or portions of Bonds which 25 are to be redeemed on that date or, in the case of optional redemptions only, the optional redemption and notice of it will be rescinded and the City's failure to deposit such amount will
not be a default. In addition, the City may at its option rescind any optional redemption and
notice of it for any reason on any date prior to the applicable Redemption Date. Notice of
rescission of an optional redemption shall be given in the same manner as notice of
redemption was originally given,

6 Official notice of redemption having been given as aforesaid, the Bonds or portions of 7 Bonds so to be redeemed shall, on the Redemption Date, become due and payable at the 8 redemption price therein specified, and from and after such date (unless such redemption and 9 notice of it shall have been rescinded or unless the City shall default in the payment of the 10 redemption price), such Bonds or portions of Bonds shall cease to bear interest. Neither the 11 failure to mail such redemption notice, nor any defect in any notice so mailed, to any particular 12 registered owner, shall affect the sufficiency of such notice with respect to other Bonds.

Notice of redemption, or notice of rescission of an optional redemption, having been
 properly given, failure of a registered owner to receive such notice shall not be deemed to
 invalidate, limit or delay the effect of the notice or redemption action described in the notice.

16 The City and the City Treasurer may treat the registered owner of this bond as the 17 absolute owner of this bond for all purposes, and the City and the City Treasurer shall not be 18 affected by any notice to the contrary.

The City Treasurer may appoint agents to serve as bond registrar or paying agent, asprovided in the Resolutions.

The Board of Supervisors certifies, recites and declares that the total amount of indebtedness of the City, including the amount of this bond, is within the limit provided by law, that all acts, conditions and things required by law to be done or performed precedent to and in the issuance of this bond have been done and performed in strict conformity with the laws authorizing the issuance of this bond, that this bond is in the form prescribed by order of the
