17	Section 1. Findings.		
18	(a) The Planning Department has determined that the actions contemplated in this		
19	ordinance comply with the California Environmental Quality Act (California Public Resource		
20	Code Sections 21000 et seq.). Said determination is on file with the Clerk of the Board of		
21	Supervisors in File No. 190049 and is incorporated herein by reference. The Board affirms		
22	this determination.		
23	(b) On _	, the Planning Commission, in Resolution No,	
24	adopted findings that the actions contemplated in this ordinance are consistent, on balance,		
25	with the City's General Plan and eight priority policies of Planning Code Section 101.1. The

18	Section 3. Effective Date. This ordinance shall become effective 30 days after				
19	enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the				
20	ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board				
21	of Supervisors overrides the Mayor's veto of the ordinance.

23	Section 4. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors				
24	intends to amend only those words, phrases, paragraphs, subsections, sections, articles,				
25	numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal				

1	Code that are explicitly shown in this ordinance as additions, deletions, Board amendment				
2	additions, and Board amendment deletions in accordance with the "Note" that appears under				
3	the official title of the ordinance.
