WHEREAS, Contractor represents and warrants that it is qualified to perform the services required by the City as set forth under the contract; and

WHEREAS, The City's Civil Service Commission approved the contract, File No. 44114-17/18 on July 10, 2018; and

WHEREAS, The Office of Contract Administration proposes to award the contract; and

WHEREAS, Contract referenced above is substantially in the form attached and are on file with the Clerk of the Board of Supervisors in File No. 181126, which is hereby declared to be a part of this Resolution as if set forth fully herein; now, therefore, be it

RESOLVED, That the Board of Supervisors authorizes the Purchaser and Director of the Office of Contract Administration to execute the contract for the Technology Marketplace purchases in the amount described above for an initial three-year term to commence following Board approval through December 31, 2021, with two one-year options to extend at the sole and absolute discretion of the City; and, be it

FURTHER RESOLVED, That within 30 days of the contract being fully executed by all parties, the Purchaser and Director of the Office of Contract Administration shall provide the final contract to the Clerk of the Board for inclusion into the official file.
