4 **Ltd. against the City and County of San Francisco for \$600,000; the lawsuit was filed on**
5 **September 12, 2017, in San Francisco Superior Court, Case No. CGC-17-561235;**
6 **entitled Sentinel Insurance Company v. City and County of San Francisco; the lawsuit**
7 **involves alleged damage from a leaking San Francisco Public Utilities Commission**
8 **pipe; and appropriating funds for this payment from the Public Utilities Commission**
9 **Water Enterprise fund balance.**

11 Be it ordained by the People of the City and County of San Francisco:

12 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
13 authorizes the City Attorney to settle the action entitled Sentinel Insurance Company, Ltd. v.
14 City and County of San Francisco, San Francisco Superior Court, Case No. CGC-17-561235
15 by the payment of \$600,000. The lawsuit involves alleged damage from a leaking San
16 Francisco Public Utilities Commission (SFPUC) pipe.

17 Section 2. The above-named action was filed in San Francisco Superior Court on
18 September 12, 2017, and the following parties were named in the lawsuit: Plaintiff: Sentinel
19 Insurance Company, Ltd., Defendant: City and County of San Francisco.

20 Section 3. The source of funding herein appropriated for use by the (SFPUC) for
21 purposes of this settlement payment in the SFPUC Water Enterprise fund balance.
