Unless the Board of Supervisors by ordinance extends the term of the Advisory Board, this Article XVIII shall expire by operation of law, and the Advisory Board shall terminate, *three years after the effective date of Ordinance No. 11-16 <u>on March 1, 2022</u>. After that date, the City Attorney shall cause this Article to be removed from the Administrative Code.*

Section 2. Effective Date. This ordinance shall become effective 30 days after enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board of Supervisors overrides the Mayor's veto of the ordinance.

Section 3. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors intends to amend only those words, phrases, paragraphs, subsections, sections, articles, numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal Code that are explicitly shown in this ordinance as additions, deletions, Board amendment additions, and Board amendment deletions in accordance with the "Note" that appears under the official title of the ordinance.
