ORDINANCE NO.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Sambou Makaloou filed a claim on June 27, 2018 against the City and County of San Francisco. The claim involves alleged property damage arising from a six inch water main break. Pursuant to Administrative Code, Section 10.22, the Board of Supervisors hereby authorizes the City Attorney to settle and compromise said claims by payment of \$124,523.97.

Section 2. The source of funding herein appropriated for use by the San Francisco Public Utilities Commission (SFPUC) for purposes of this settlement payment is the SFPUC Wastewater Enterprise fund balance.
