2 ESTABLISHING WARDS FOR PROPOSED MUNICIPAL UTILITY DISTRICT ELECTION.

A petition has been circulated, and referred to the Board of Supervisors by the San Francisco Local Agency Formation Commission, for submission to the voters proposing formation of a Municipal Utility District.

NOW, THEREFORE, BE IT MOVED, That pursuant to California Public Utilities Code section 11642, wards for the proposed Municipal Utility District are hereby established, bounded and described as follows:

FIRST WARD shall comprise all of that portion of the City and County of San Francisco commencing at the point of intersection of the shoreline of the Pacific Ocean and a straightline extension of Lincoln Way; thence easterly along Lincoln Way to Nineteenth Avenue; thence southerly along Nineteenth Avenue to Judah Street continuing on Parnassus Avenue; thence easterly along a straight-line extension of Parnassus Avenue to the western boundary of the campus of the University of California San Francisco; thence generally northeasterly along the northern boundary of the said campus; thence generally southerly, southeasterly, easterly and northeasterly along the eastern and northeastern boundary of said campus to intersect Stanyan Street; thence southerly in a straight line extension of Stanyan Street to Clarendon Avenue; thence easterly and northeasterly along Clarendon Avenue to Twin Peaks Boulevard; thence northeasterly along Twin Peaks Boulevard to Clayton Street; thence northerly along Clayton Street to Ashbury Street; thence northeasterly and north along Ashbury Street to Frederick Street; thence easterly along Frederick Street to Buena Vista Avenue West; thence southerly along Buena Vista Avenue West and along the southeasterly boundary of Buena Vista Park to Buena Vista Avenue East; continuing on Buena Vista Avenue East easterly and northeasterly along the boundaries of said park to the intersection with Duboce Avenue; thence easterly along Duboce Street to Market Street; thence

1 northeasterly along Market Street to Laguna Street; thence northerly along Laguna Street to 2 California Street; thence westerly along California Street to Presidio Avenue; thence southerly along Presidio Avenue to Geary Boulevard; thence easterly along Geary Boulevard to St. 3 4 Joseph's Avenue; thence southeasterly and southerly along St. Joseph's Avenue to Turk 5 Boulevard; thence westerly along Turk Boulevard to Masonic Avenue; thence southerly along Masonic Avenue to Fulton Street; thence westerly along Fulton Street to Parker Avenue; 6 7 thence northerly along Parker Avenue to Lone Mountain Terrace; thence westerly along Lone 8 Mountain Terrace to Stanyan Boulevard; thence northerly along Stanyan Boulevard to Geary 9 Boulevard; thence westerly along Geary Boulevard to Arguello Boulevard; thence northerly 10 along Arquello Boulevard to Lake Street; thence westerly along Lake Street to Twenty-11 Seventh Avenue; thence southerly along Twenty-Seventh Avenue to California Street; thence 12 westerly along California Street to its point of intersection with the eastern boundary of Lincoln 13 Park; thence northerly along said boundary to the shoreline of the Pacific Ocean; thence 14 westerly and southerly along said shoreline to the point of commencement. Unless specifically 15 designated to the contrary, all references to streets, boulevards, drives, avenues, terraces and 16 ways contained in the foregoing description shall refer to the centerlines of said streets, 17 boulevards, drives, avenues, terraces and ways, respectively.

SECOND WARD, shall comprise all of that portion of the City and County of San Francisco commencing at the point of intersection of the shoreline of the Pacific Ocean and the eastern boundary of Lincoln Park; thence southerly along said boundary to California Street; thence easterly along California Street to Twenty-Seventh Avenue; thence northerly along Twenty-Seventh Avenue to Lake Street; thence easterly along Lake Street to Arguello Boulevard; thence southerly along Arguello Boulevard to Geary Boulevard; thence easterly along Geary Boulevard to Stanyan Boulevard; thence southerly along Stanyan Boulevard to Lone Mountain Terrace; thence easterly along Lone Mountain Terrace to Parker Avenue;

| include Yerba Buena and Treasure Islands. Unless specifically designated to the contrary, all |
| references to streets, boulevards, drives, avenues, terraces and ways contained in the |
| foregoing description shall refer to the centerlines of said streets, boulevards, drives, avenues |
| terraces and ways, respectively. |

FIFTH WARD, shall comprise all of that portion of the City and County of San Francisco and the City of Brisbane commencing at the point of intersection of a northeasterly straight-line extension of Mission Street and the shoreline of San Francisco Bay; thence southwesterly along said straight-line extension of Mission Street to the Embarcadero; thence northwesterly along the Embarcadero to the intersection with a northeasterly straight-line extension of Market Street; thence southwesterly along Market Street to Powell Street; thence northerly along Powell Street to Ellis Street; thence westerly along Ellis Street to Mason Street; thence northerly along Mason Street to Post Street; thence westerly along Post Street to Larkin Street; thence southerly along Larkin Street to Ellis; thence westerly along Ellis Street to Gough Street; thence southerly on Gough Street to Eddy Street; thence westerly along Eddy Street to Laguna Street; thence southerly along Laguna Street to Market Street; thence northeasterly along Market Street to Guerrero Street; thence southerly along Guerrero Street to Seventeenth Street; thence easterly along Seventeenth Street to the centerline of the James Lick Freeway (State Route 101); thence generally southerly along the centerline of the James Lick Freeway (State Route 101) to the interchange with the Southern Freeway (Interstate Route 280); thence generally southeasterly along the centerline of the Southern Freeway (Interstate Route 280) to the intersection with a northerly straight-line extension of Bowdoin Street; thence southerly along that straight-line extension and Bowdoin Street to
