5	RESOLVED, That, in accordance with the provisions of the California Vehicle Code and the
6	San Francisco Traffic Code, the following regulations governing the parking of vehicles are
7	hereby enacted or rescinded as designated below:
8	PERPENDICULAR (90-DEGREE ANGLE) PARKING - ESTABLISH
9	Connecticut Street, east side, between 18th and 20th Streets
10	Mississippi Street, both sides, between 20th and 22nd Streets
11	Mississippi Street, east side, between Mariposa and 20th Streets
12	Missouri Street, both sides, between 19th and Mariposa Streets
13 14	Missouri Street, east side, between 20th and Sierra Streets
14	
	Missouri Street, west side, between 17th and Mariposa Streets
16	Missouri Street, west side, between 19th and 20th Streets
17	Pennsylvania Street, both sides, between 19th and 22nd Streets
18	Pennsylvania Street, west side, between 18th and Mariposa Streets
19	Texas Street, both sides, between 17th and 19th Streets
20	
21	Texas Street, east side, between 19th and 20th Streets
22	Texas Street, east side, from 20th Street to a point 95 feet south of Sierra Street
23	Texas Street, west side, from 20th Street to a point 65 feet north of Sierra Street

5	Carr Street, both sides, between Paul and Salinas Avenues (unit block)

14	Castro Street, both sides, between 21st and Hill Streets (northern portion of 800 block)
15 16	UNMETERED MOTORCYCLE PARKING - ESTABLISH
17	17th Street, north side, from 43.5 feet to 72 feet east of Folsom Street (28.5-foot zone, accommodating 7 motorcycles, in front of #3084-17th Street)
