

Premises (a former self-serve laundromat) is not suitable for alcohol sales, as this is a 100% guiet residential area, with no resale businesses on California Street from 8th Avenue to 12th Avenue.

There already exist at least four (4) 21 - Off sale general premises less than 4 blocks away located at; 1) 841 Clement St. (Cable Car Wine and Spirits, 2) 707-719 Clement St. (Richmond New May Wah Supermarket), 3)1042 Clement St. (Healthy Spirits), and 4) 4400 California St. (Park Presidio Liquors).

Accordingly, zoning is improper for alcohol sales at 4800 California Street, and license should be denied.
