WHEREAS, Porky's Palace, LLC is seeking the issuance of a Type-20 off-sale beer and wine liquor license for the service premise doing business as Tank18, located at 1345 Howard Street (District 6); and

WHEREAS, The Planning Department has verified that the area is properly zoned and recommends approval; and

WHEREAS, The Police Department has filed zero protests and zero letters of support with the Department of Alcoholic Beverage Control under California Business and Professions Code, Section 24013, and recommends that the Department of Alcoholic Beverage Control issue the liquor license with conditions; and

WHEREAS, The conditions recommended by the Police Department are the following: 1) full and complete meals must be offered and made available at all times the premises is exercising the privileges of its alcoholic beverage license, with the exception of the last 1/2 hour of operation each day; 2) sales of alcoholic beverages shall be permitted between the hours of 10:00 a.m. to 12:00 a.m. each day of the week; 3) petitioner(s) shall actively monitor the area under their control in an effort to prevent the loitering of persons on any property adjacent to the licensed premises as

depicted on the most-recently-certified ABC-253; 4) no noise shall be audible at any nearby residences and 2 consideration points; 5) the petitioner(s) shall be responsible for maintaining free of litter the area adjacent to the premises over which they have control as depicted on the most-recently-certified ABC-257 and ABC-253; and 6) any graffiti painted or marked upon the premises on any adjacent area under the control of the licensee(s) shall be removed or painted-over within 72 hours of being applied; now therefore, be it

RESOLVED, That in accordance with California Business and Professions Code, Section 23958.4, the Board of Supervisors of the City and County of San Francisco hereby determines that the transfer of a Type-20 off-sale beer and wine liquor license to Porky's Palace, LLC, doing business as Tank18, located at 1345 Howard Street (District 6), will serve the public convenience or necessity of the City and County of San Francisco; and, be it
