7	ordinance shall only take effect if a charter amendment creating a Small Business

12	Be it ordained by the People of the City and County of San Francisco:

14	Section 1. The San Francisco Administrative Code is hereby amended by adding		
15	Section 2A.240, to read as follows:		
16	Article XVI: Small Business Commission		
17	SEC. 2A.240. SMALL BUSINESS COMMISSION; POWERS AND DUTIES.		
18	(a) The Small Business Commission shall:		
19	1. Formulate and evaluate goals, objectives, plans, and programs and set policies for the		
20	City regarding small businesses, consistent with any overall objectives established by the Mayor and		
21	the Board of Supervisors through the adoption of legislation, in order to promote the economic health		
22	of the small business community in San Francisco, its employees, and its customers;		
23	2. Develop and keep current an annual statement of purpose outlining its areas of		
24	jurisdiction, authorities, purpose and goals, subject to review and approval by the Mayor and the		
25	Board of Supervisors;		

1	<u>3.</u>	Recommend to the Mayor for submission to the Board of Supervisors rates, fees and	
2	similar charg	ges with respect to appropriate items coming within its jurisdiction;	
3	<u>4.</u>	Appoint a commission secretary who shall serve at the pleasure of the Commission;	
4	<u>5.</u>	Prepare and recommend to the Mayor an annual budget for the Commission's activities;	
5	<u>6.</u>	Administer grants and programs concerning and benefiting small businesses and	
6	<u>neighborhoo</u>	d business districts;	
7	<u>7.</u>	Review all legislation affecting small businesses and make recommendations to the	
8	Board of Sup	pervisors;	
9	<u>8.</u>	Review rules and regulations adopted by City departments that affect small businesses	
10	and recomm	end modifications that would promote the health of small businesses;	
11	<u>9.</u>	Collect and analyze information about the small business economy in San Francisco, as	
12	well as cond	uct investigations under its power of inquiry into any aspect of governmental operations	
13	affecting sma	all businesses, including holding hearings and taking testimony, and make	
14	<u>recommenda</u>	tions to the Mayor or the Board of Supervisors; and	
15	<u>10.</u>	Exercise such other powers and duties as shall be prescribed by the Board of	
16	Supervisors.		
17	<u>(b)</u>	The Commission may adopt such rules and regulations consistent with the provisions of	
18	this Section o	as are necessary for the conduct of its business. Such rules and regulations shall be	
19	available for	public review and comment for 10 days before they are finally adopted by the	
20	Commission.

22	Sect	ion 2. The San Francisco Administrative Code is hereby amended by repealing	
23	Sections 5.120, 5.121, and 5.122, in their entirety.		
24	SEC. 5.120.	SMALL BUSINESS COMMISSION.

1	There shall be a Small Business Commission in the Department of Business and Economic
2	Development. The Commission shall consist of seven members, who shall serve at the pleasure of the
3	Mayor. The Mayor shall designate three of his or her initial appointments to serve for two-year terms
4	Thereafter, all commissioners shall serve for four-year terms.
5	The Commission shall not have a separate budget, but shall be included in the budget for the
6	Department of Business and Economic Development.
7	
8	SEC. 5.121. POWERS AND DUTIES.
9	(a) The Small Business Commission shall:
10	1. Formulate and evaluate goals, objectives, plans, and programs and set policies for the
11	City regarding small businesses, consistent with any overall objectives established by the Mayor and
12	the Board of Supervisors through the adoption of legislation;
13	2. Develop and keep current an annual statement of purpose outlining its areas of
14	jurisdiction, authorities, purpose and goals, subject to review and approval by the Mayor and the
15	Board of Supervisors;
16	3. Recommend to the Mayor for submission to the Board of Supervisors rates, fees and
17	similar charges with respect to appropriate items coming within its jurisdiction;
18	4. Advise the Mayor regarding the appointment and removal of a director and a secretary
19	of the Commission;
20	5. Make recommendations to the Mayor regarding that portion of the budget for the
21	Department of Business and Economic Development to be allocated to the Commission and the Office
22	of Small Business Affairs;
23	6. Conduct investigations under its power of inquiry into any aspect of governmental
24	operations affecting small businesses, including holding hearings and taking testimony, and make
25	recommendations to the Mayor or the Board of Supervisors; and

1	7. Exercise such other powers and duties as shall be prescribed by the Board of
2	Supervisors.
3	(b) The Commission may adopt such rules and regulations consistent with the provisions of
4	this Article as are necessary for the conduct of its business. Such rules and regulations shall be
5	available for public review and comment for 10 days before they are finally adopted by the Commission
6	
7	SEC. 5.122. DEPARTMENT OF BUSINESS AND ECONOMIC DEVELOPMENT'S OFFICE OF
8	SMALL BUSINESS AFFAIRS.
9	There shall be an Office of Small Business Affairs in the Department of Business and Economic
10	Development. The director of the Small Business Commission shall also be the administrative head of
11	the Office of Small Business Affairs.
12	
13	Section 3. This ordinance shall only take effect if a charter amendment creating a
14	Small Business Commission in the San Francisco Charter is adopted at the November 4,
15	2003 election. This ordinance shall take effect on the same date that such charter
16	amendment takes effect.
