ORDINANCE NO.

1	[Establishing the powers and duties of the Small Business Commission.]
2	
3	Ordinance amending the San Francisco Administrative Code by adding Section 2A.240,
4	to list the powers and duties of the Small Business Commission, and by repealing
5	Sections 5.120, 5.121, and 5.122, dealing with the former Small Business Commission,
6	and by re-numbering Section 10.100-129 as Section 10.100-333, and providing that the
7	ordinance shall only take effect if a charter amendment creating a Small Business
8	Commission in the Charter is adopted at the November 2003 election.

11	Board amendment deletions are strikethrough normal.
12	Be it ordained by the People of the City and County of San Francisco:
13	Section 1. The San Francisco Administrative Code is hereby amended by adding
14	Section 2A.240, to read as follows:
15	Article XVI: Small Business Commission
16	SEC. 2A.240. SMALL BUSINESS COMMISSION; POWERS AND DUTIES.
17	(a) The Small Business Commission shall:
18	1. Formulate and evaluate goals, objectives, plans, and programs and set policies
19	for the City regarding small businesses, consistent with any overall objectives established by the Mayor
20	and the Board of Supervisors through the adoption of legislation, in order to promote the economic
21	health of the small business community in San Francisco, its employees, and its customers;
22	2. Develop and keep current an annual statement of purpose outlining its areas of
23	jurisdiction, authorities, purpose and goals, subject to review and approval by the Mayor and the
24	<u>Board of Supervisors;</u>

1	3. Recommend to the Mayor for submission to the Board of Supervisors rates, fees
2	and similar charges with respect to appropriate items coming within its jurisdiction;
3	4. Prepare and recommend to the Mayor an annual budget for the Commission's
4	<u>activities;</u>
5	5. Oversee grants and programs concerning and benefiting small businesses and
6	neighborhood business districts;
7	6. Review all legislation affecting small businesses and make recommendations to
8	the Board of Supervisors;
9	7. <i>Review rules and regulations adopted by City departments that affect small</i>
10	businesses and recommend modifications that would promote the health of small businesses;
11	8. <i>Collect and analyze information about the small business economy in San</i>
12	Francisco, as well as conduct investigations under its power of inquiry into any aspect of governmental
13	operations affecting small businesses, including holding hearings and taking testimony, and make
14	recommendations to the Mayor or the Board of Supervisors; and
15	(b) The Commission may adopt such rules and regulations consistent with the provisions of
16	this Section as are necessary for the conduct of its business. Such rules and regulations shall be
17	available for public review and comment for 10 days before they are finally adopted by the
18	<u>Commission.</u>

20	Section 2. The San Francisco Administrative Code is hereby amended by repealing
21	Sections 5.120, 5.121, and 5.122, in their entirety.
22	
23	SEC. 5.120. SMALL BUSINESS COMMISSION.
24	There shall be a Small Business Commission in the Department of Business and Economic
25	Development. The Commission shall consist of seven members, who shall serve at the pleasure of the

1	Mayor. The Mayor shall designate three of his or her initial appointments to serve for two-year terms.
2	Thereafter, all commissioners shall serve for four-year terms.
3	The Commission shall not have a separate budget, but shall be included in the budget for the
4	Department of Business and Economic Development.
5	
6	SEC. 5.121. POWERS AND DUTIES.
7	(a) The Small Business Commission shall:
8	1. Formulate and evaluate goals, objectives, plans, and programs and set policies for the
9	City regarding small businesses, consistent with any overall objectives established by the Mayor and
10	the Board of Supervisors through the adoption of legislation;
11	2. Develop and keep current an annual statement of purpose outlining its areas of
12	jurisdiction, authorities, purpose and goals, subject to review and approval by the Mayor and the
13	Board of Supervisors;
14	3. Recommend to the Mayor for submission to the Board of Supervisors rates, fees and
15	similar charges with respect to appropriate items coming within its jurisdiction;
16	4. Advise the Mayor regarding the appointment and removal of a director and a secretary
17	of the Commission;
18	5. Make recommendations to the Mayor regarding that portion of the budget for the
19	Department of Business and Economic Development to be allocated to the Commission and the Office
20	of Small Business Affairs;
21	6. Conduct investigations under its power of inquiry into any aspect of governmental
22	operations affecting small businesses, including holding hearings and taking testimony, and make
23	recommendations to the Mayor or the Board of Supervisors; and
24	7. <i>Exercise such other powers and duties as shall be prescribed by the Board of</i>
25	Supervisors.

1	(b) The Commission may adopt such rules and regulations consistent with the provisions of
2	this Article as are necessary for the conduct of its business. Such rules and regulations shall be
3	available for public review and comment for 10 days before they are finally adopted by the Commission
4	
5	SEC. 5.122. DEPARTMENT OF BUSINESS AND ECONOMIC DEVELOPMENT'S OFFICE OF
6	SMALL BUSINESS AFFAIRS.
7	There shall be an Office of Small Business Affairs in the Department of Business and Economic
8	Development. The director of the Small Business Commission shall also be the administrative head of
9	the Office of Small Business Affairs.
10	
11	Section 3. This ordinance shall only take effect if a charter amendment creating a
12	Small Business Commission in the San Francisco Charter is adopted at the November 4,
13	2003 election. This ordinance shall take effect on the same date that such charter
14	amendment takes effect.
