[Donation of Retired Ambulance to San Francisco Unified School District]

Resolution authorizing the Fire Department to donate a retired ambulance to the San Francisco Unified School District's Health Academy at John O'Connell High School.

WHEREAS, The San Francisco Unified School District's (SFUSD's) Health Academy is a program that assists high school students in not only their high school level health science classes but also enrollment in City College of San Francisco Emergency Medical Technician (EMT) courses; and

WHEREAS, A large part of Emergency Medical Services (EMS) training focuses on manipulative skills and the best way to learn those skills is to practice on genuine equipment; and

WHEREAS, EMS equipment is expensive and difficult to obtain; and

WHEREAS, Vehicle 145-737, a 2000 Ford F-450 Ambulance, has been retired from service by the Fire Department even as a relief piece and has been identified for the purposes of this donation; and

WHEREAS, The Fire Department wishes to donate one retired ambulance for educational purposes to the Health Academy; and

WHEREAS, This ambulance would serve as a valuable teaching and training tool for students in the Health Academy program, and the Health Academy would benefit from this vehicle as a training aid; and

WHEREAS, On September 13, 2017, the Fire Commission adopted Resolution No. 2017-03, recommending that the Board of Supervisors approve the donation of a retired ambulance to the SFUSD; and

WHEREAS, The Fire Commission Resolution is on file with the Clerk of the Board of Supervisors in File No. <u>190103</u>, which is hereby declared to be a part of this resolution as if set forth fully herein; and

WHEREAS, Chapter 21 of the Municipal Code allows for commodities that have been declared as surplus to be disposed of in a manner that will best serve the interests of the City and will maximize the City's economic return on the surplus commodities by donating to public entities, non-profit organizations and schools; and

WHEREAS, The SFUSD's Health Academy at John O'Connell High School is a program designed to assist students in health sciences as well as expose EMS training and career opportunities to students; and

WHEREAS, This ambulance is for instructional purposes only, and will not be operated, driven or used for actual patient care; now, therefore, be it

RESOLVED, That the San Francisco Fire Department is authorized to donate vehicle 145-737 to SFUSD's Health Academy at John O'Connell High School.

WHEREAS, the San Francisco Unified School District's (SFUSD's) Health Academy is a program that assists high school students in not only their high school level health science classes but also enrollment in City College of San Francisco Emergency Medical Technician (EMT) courses; and,

WHEREAS, a large part of Emergency Medical Services (EMS) training focuses on manipulative skills and the best way to learn those skills is to practice on genuine equipment; and,

WHEREAS, EMS equipment is expensive and difficult to obtain; and

WHEREAS, the San Francisco Fire Department has recently taken receipt of two new ambulances, allowing the Department to replace old ambulances that were no longer of operational use to the Department; and,

WHEREAS, the San Francisco Fire Department wishes to donate one retired ambulance for educational purposes to the Health Academy; and,

Whereas, vehicle 145-737, a 2000 Ford F-450 Ambulance, has been retired from service even as a relief piece and has been identified for the purposes of this donation; and,

WHEREAS, this ambulance would serve as a valuable teaching and training tool for students in the Health Academy program, and the Health Academy would benefit from this vehicle as a training aid; now, therefore, be it

RESOLVED, that the San Francisco Fire Department and Fire Commission recommend donating one obsolete ambulance to the SFUSD's Health Academy at John O'Connell High

School. In the event the SFUSD should close the Health Academy program or the program is no longer in existence, the Fire Department would like the ambulance to be donated to another institution for educational purposes or to be disposed of in an appropriate manner.
