10	Section 1. Making Environmental Findings.
11	(a) In Resolution No03, this Board of Supervisors adopted findings in connection with
12	its consideration of this Ordinance establishing rates for the Golden Gate Park Concourse
13	Underground Parking Facility under California Environmental Quality Act ("CEQA") (California
14	Public Resources Code Section 21000 et seq.), the State CEQA Guidelines (California Code of
15	Regulations Title 14 Sections 15000 et seq.), and Chapter 31 of the San Francisco Administrative Code
16	and adopted a mitigation monitoring program, which findings and program are hereby incorporated by
17	reference herein. A copy of said resolution is on file with the Clerk of the Board in File No.

20	with the General Plan, Planning Code Section 101.1 and the Golden Gate Park Master Plan
