9 WHEREAS, Upon completion of a competitive selection process, the Airport  
10 Commission adopted Resolution No. 18-0232 on August 7, 2018, awarding the Electronics  
11 Stores Lease in Terminal 3 Boarding Areas E and F to InMotion Entertainment Group, LLC;

13 WHEREAS, The Electronics Stores Lease in Terminal 3 Boarding Areas E and F –  
14 Lease No. 18-0232 has a term of ten years, and an initial minimum annual guarantee of  
15 \$500,000 now, therefore, be it

16 RESOLVED, That this Board of Supervisors hereby approves Electronics Stores Lease  
17 in Terminal 3 Boarding Areas E and F – Lease No. 18-0232, a copy of which is on file with the  
18 Clerk of the Board of Supervisors in File No. 181177; and, be it

19 FURTHER RESOLVED, That within thirty (30) days of the lease being fully-executed by  
20 all parties, the Airport Commission shall provide the final lease to the Clerk of the Board for  
21 inclusion into the official file.
