13 WHEREAS, The Electronics Store Lease in International Terminal Boarding Area A –
14 Lease No. 18-0231 has a term of ten years, and an initial minimum annual guarantee of
15 \$340,000; now, therefore, be it

16 RESOLVED, That this Board of Supervisors hereby approves the Electronics Store
17 Lease in International Terminal Boarding Area A – Lease No. 18-0231, a copy of which is on
18 file with the Clerk of the Board of Supervisors in File No. 181178; and, be it

19 FURTHER RESOLVED, That within thirty (30) days of the lease being fully-executed by
20 all parties, the Airport Commission shall provide the final lease to the Clerk of the Board for
21 inclusion into the official file.
