3	Ordinance amending Traffic Code by amending Sections 63 and 63 (a) thereof, relating
4	to commercial vehicle parking in certain use districts.

7	Be it ordained by the People of the City and County of San Francisco:
8	Section 1. The Traffic Code is hereby amended by amending Section 63, to read as
9	follows:
10	Sec.63 COMMERCIAL VEHICLES; PARKING LIMITED IN CERTAIN USE
11	DISTRICTS. It shall be unlawful for the operator of any motor truck, truck tractor, road
12	tractor, van, trailer, delivery wagon, or any vehicle with a manufacturer's gross vehicle weight
13	rating in excess of 10,000 pounds and used for commercial purposes, except vehicles of
14	public utilities and construction equipment engaged in repair or construction, to park or leave
15	standing for a period in excess of one hour any such vehicle in any street in an RH-1(D), RH-
16	1, RH-2, RH-3, RM-1, RM-2, RM-3, RM-4 or P Use District, except when in the course of
17	delivery or removal of goods, merchandise or other personal property for residents on such
18	street or except when such vehicle is used by a recreational equipment vendor as defined in
19	Section 1050 of the Police Code in the course of his business and all the requirements of
20	Police Code Sections 1051, 1052, 1053, 1054 and 1055 are met. Any excepted vehicle shall
21	be subject to all parking limitations applicable thereto as otherwise provided by law.
22	Section 2. The Traffic Code is hereby amended by amending Section 63 (A) to read as
23	follows:
24	Sec.63 (A). COMMERCIAL VEHICLES; PARKING PROHIBITED IN CERTAIN USE
25	DISTRICTS BETWEEN 2:00 A.M. AND 6:00 A.M. It shall be unlawful for the operator of any

1	motor truck, truck tractor, road tractor, trailer, delivery wagon or any vehicle with a
2	manufacturer's gross vehicle weight rating of over 10,000 pounds and used for commercial
3	purposes to park or leave standing any such vehicle in any street in an RH-1(D), RH-1, RH-2
4	RH-3, RM-1, RM-2, RM-3, RM-4 or P Use District between the hours of 2:00 A.M. and 6:00
5	A.M. This provision shall not apply to vehicles of public utilities and construction equipment
6	engaged in repair or construction work at or near the location at which the vehicle is parked.
