1 [Parking Regulations.]

### Resolution enacting and rescinding parking regulations at various locations.

RESOLVED, That, in accordance with the provisions of the California Vehicle
 Code and the San Francisco Traffic Code, the following regulations governing the

5 parking of vehicles are hereby enacted or rescinded as designated below:

## 7 UNMETERED MOTORCYCLE PARKING ESTABLISH

8 Frederick Street, north side, from Delmar Street to 9 feet westerly.

### 9 PERPENDICULAR (90-DEGREE ANGLE) PARKING - ESTABLISH

- 10 Rhode Island Street, west side, between 15<sup>th</sup> and Alameda Streets (100 block), legalizing existing conditions; and

- 12 Cunningham Place, south side (60-foot zone), legalizing existing conditions.

#### 13 NO PARKING ANYTIME - ESTABLISH

14 Cunningham Place, at the terminus between the north and south curbs (40-foot 2000).

#### 16 TOW-AWAY, NO STOPPING ANYTIME - RESCIND TOW-AWAY, NO PARKING ANYTIME - ESTABLISH
