6	Be it ordained by the People of the City and County of San Francisco:						
7	Section 1.						
8	Section 1.1B of Ordinance No. 198-04 (Annual Salary Ordinance, 2004/2005) is hereby						
9	amended to add Section 1.1B(J), to read as follows:						
10	Section 1.1B. With the exception indicated in F, the Human Resources Director is						
11	solely authorized to administratively amend this ordinance as follows:

13	J. With the approval of the Controller and the Director of the Office of Emergency Services, to change the classification of a vacant position funded by federal grant						
14	funds awarded for the purpose of enhancing security and overall preparedness to prevent, respond to, and recover from acts of terrorism, provided that the services						
15	are in the same functional area and any increased rate of pay, when considered						
16	with all other classification changes, will not increase the total rate of pay of all positions funded by the grant. Federal grant funds include federal monies awarded						
17	to the City through the state or other governmental entities.
