10	forty-two months for the purpose of controlling lead based paint in eligible rental housing units		
11	and homeowner occupied housing units constructed before 1978; and		
12	WHEREAS, On September 27, 2004, the Director of the Mayor's Office of Housing		
13	("MOH") entered into an agreement with HUD to accept the Grant; and		
14	WHEREAS, Under the Grant agreement HUD requires the City to submit its work		
15	program and proposed budget within 60 days for HUD review and approval, and to		
16	commence operation of the lead hazard reduction program funded by the Grant no later than		
17	March 31, 2005; and		
18	WHEREAS, MOH has prepared an Expenditure Schedule for the use of the Grant on		
19	file with the Clerk of the Board of Supervisors in File No, which is hereby		
20	declared to be part of this resolution as if set forth fully herein; now, therefore, be it		
21	RESOLVED, That the Board of Supervisors hereby authorizes the Director of MOH, on		
22	behalf of the City, retroactively to accept and to expend the Grant from HUD; and, be it
