3	Ordinance amending S. F. Health Code Sec. 41.4 to authorize the Animal Care and
4	Control Department to investigate complaints regarding animal care at the San
5	Francisco Zoo and to work with the Recreation and Park Department and the Director
6	of the Zoo to remedy any deficiencies in animal care.

10	Be it ordained by the People of the City and County of San Francisco:
11	Section 1. The San Francisco Health Code is hereby amended by amending Section
12	41.4, to read as follows:
13	Sec. SEC. 41.4. ANIMAL CARE AND CONTROL DEPARTMENT; ESTABLISHMENT;
14	APPOINTMENT OF ANIMAL CONTROL OFFICER; POWERS AND DUTIES OF ANIMAL
15	CARE AND CONTROL DEPARTMENT.
16	(a) Effective July 1, 1989, there is hereby established an Animal Care and
17	Control Department under the jurisdiction of the City Administrator. The Department shall
18	consist of a Director and such employees and assistants as may be necessary to carry out the
19	work and functions of the Department. The City Administrator shall appoint an Animal Control
20	Officer who shall serve at the pleasure of the City Administrator as the Director of the Animal
21	Care and Control Department.
22	(b) The Animal Care and Control Department shall have the following
23	functions:
24	(1) To operate an animal shelter;

1 (2) To provide nourishment and medical care for animals in its care; basic 2 health screening for all animals and a disease control program for the facility; vaccination of 3 animals; euthanasia of animals by barbiturate injection or other humane methods; sale of dog 4 licenses; volunteer programs; information on animal control laws, pet owner or guardian 5 responsibilities and pet care; and maintenance of records of all animal control activities;

6 (3) To enforce the provisions of this Article and any other ordinances and 7 laws that pertain to the care and control of animals;

8 (4) To charge and collect the fees, fines and deposits as required by this
9 Article and any other ordinances and laws that pertain to the care and control of animals; and

10 (5) To carry out the duties and functions of the Animal Control Officer as 11 defined in Article I of this Code, Section 985 of this Code, Sections 220 through 221.3 of the 12 San Francisco Business and Tax Regulations Code, and any other ordinances and laws 13 pertaining to the care and control of animals.

- 14 (6) To investigate complaints regarding the condition or care of animals at the San
 15 Francisco Zoo. The Director shall make recommendations to, and work with, the Recreation and Park
 16 Department and the Director of the Zoo to remedy any deficiencies in animal care in accordance with
 17 federal, state and local law.
