15 insurance and maintenance, of which \$424,340 is retroactive, and \$1,223,777 will be used to  
16 fund environmental consulting services.

18 Section 3. Placing \$1.00 on Finance Committee Reserve with the condition that the three  
19 natural gas-fired combustion turbines cannot be operational until the PG&E Hunter's Point  
20 Power Plant (HPPP) is closed; and further that CAISO cancel the RMR contract for the  
21 Potrero Power Plant by December 30, 2007.
