[Settlement of Lawsuit - Winfield International, Inc. - \$500,000]

Ordinance authorizing settlement of the lawsuit filed by Winfield International, Inc. against the City and County of San Francisco for a payment by Winfield International, Inc. of \$500,000; the lawsuit was filed on March 20, 2017, in San Francisco Superior Court, Case No. CPF-17-515532 (Appeal No. A153209); entitled Winfield International, Inc. v. City and County of San Francisco; the lawsuit challenges the City's enforcement of the Below Market Rate housing conditions of approval applicable to Petitioner's real property located at 3000 23rd Street; other material terms of the settlement include recording a notice of special restrictions reflecting the Below Market Rate conditions of Approval applicable to the real property; and a 12-month extension and related lease terms for the current tenant of Unit No. 205.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled Winfield International, Inc. v. City and County of San Francisco, San Francisco Superior Court, Case No. CPF-17-515532 (Appeal No. A153209) by the payment by Winfield International, Inc. of \$500,000; recording a notice of special restrictions reflecting the Below Market Rate conditions of Approval applicable to the real property located at 3000 23rd Street ("Property"); and a 12-month extension and related lease terms for the current tenant of Unit No. 205. The lawsuit involves a challenge to the City's enforcement of the Below Market Rate (BMR) Conditions of Approval imposed on Petitioners' property in connection with the Conditional Use Authorization and the subdivision map approval for the Property.
