[Settlement of Lawsuit - Logan Rachel Ury - \$80,000]

Ordinance authorizing settlement of the lawsuit filed by Logan Rachel Ury against the City and County of San Francisco for \$80,000; the lawsuit was filed on February 14, 2017, in San Francisco Superior Court, Case No. CGC-17-557062; entitled Logan Rachel Ury v. City and County of San Francisco, et al.; the lawsuit involves an alleged personal injury in Golden Gate Park.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled Logan Rachel Ury v. City and County of San Francisco, et. al., San Francisco Superior Court Case No. CGC-17-557062 by the payment of \$80,000. The lawsuit involves an alleged personal injury in Golden Gate Park.

Section 2. The above-named action was filed in San Francisco Superior Court on February 14, 2017, and the following parties were named in the lawsuit: Logan Rachel Ury, Plaintiff; City and County of San Francisco, Defendant.


