Ordinance authorizing settlement of the lawsuit filed by Jamal Rashid Trulove against the City and County of San Francisco for \$13,100,000; the lawsuit was filed on January 7, 2016, in United States District Court, Case No. 16-cv-00050; entitled Jamal Rashid Trulove v. Maureen D'Amico et al.; the lawsuit involves alleged unlawful prosecution and incarceration.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled Jamal Rashid Trulove v. Maureen D'Amico et al., United States District Court, Case No. 16-cv-00050 by the payment of \$13,100,000. The lawsuit involves alleged unlawful prosecution and incarceration.

Section 2. The above-named action was filed in Unites States District Court on January 7, 2016, and the following parties were named in the lawsuit: Plaintiff: Jamal Rashid Trulove; Defendants: Maureen D'Amico and Michael Johnson.
