1	[Temporary Occupancy of Commercial Vehicle Parking Meters.]

3	Resolution enacting temporary occupancy of a portion of the commercial vehicle
4	parking meters on the north side of Post Street between Kearny and Montgomery from
5	8:30am to 5:00pm on every Thursday beginning July 14, 2005 through November 30,
6	2005.

8	WHEREAS, Farmers' markets provide the opportunity for consumers to purchase fresh
9	organic fruits and vegetables; and
10	WHEREAS, Farmers' markets create opportunities for market goers to gather together
11	and help enhance a sense of community within a neighborhood; and
12	WHEREAS, Increasing walking traffic in neighborhood commercial districts tends to
13	enhance the overall economic vitality of the district; and
14	WHEREAS, Food sold and purchased at farmers' markets travels a shorter distance
15	from field to table than most food in the grocery store thus saving fuel and helping to protect
16	the environment; and
17	WHEREAS, The Sustainability Plan for the City and County of San Francisco, adopted
18	by the Board of Supervisors in 1997, lists access to nutritious, affordable, and safe food as a
19	principle goal; and
20	WHEREAS, The Sustainability Plan identifies creating farmers' markets in every
21	neighborhood in San Francisco as a long-term objective; and,
22	WHEREAS, The San Francisco Certified Farmers' Market at the Crocker Galleria
23	would provide residents with access to fruits and vegetables that will help Financial District
24	market goers meet their nutritional needs; and,

1	WHEREAS, ISCOTT approval of the temporary occupancy of commercial vehicle
2	parking meters will be filed with the Clerk of the Board of Supervisors in File No. , which is
3	hereby declared to be a part of this resolution as set forth fully herein; and,
4	WHEREAS, The Board of Supervisors is the appropriate policy body to approve an
5	extended temporary occupancy permit; now, therefore, be it
6	RESOLVED, That in accordance with the provisions of the California Vehicle code and
7	the San Francisco Traffic Code, the following regulation governing the movement of vehicles
8	is hereby enacted as designated below.

14	for a Certified Farmers' Market.
