1	[Judicial Review of the Ogoni Nine]
2	
3	Resolution urging the Government of Nigeria to conduct a full judicial review of the
4	trial of the Ogoni Nine, make reparations to the survivors of the Ogoni Nine, increase
5	social spending for the Ogoni and the Niger Delta as a whole, ensure that all members
6	of the security forces receive training in international standards on the use of force
7	and firearms, in particular the 1979 UN Code of Conduct for Law Enforcement Officials
8	and the 1990 UN Basic Principles on the Use of Force and Firearms by Law Enforcement Officials.
9	
10	Whereas, on November 10, 1995, Ken Saro-Wiwa, Nigerian writer, environmental
11	activist and nominee for the Nobel Peace Prize, and eight colleagues were hanged by the
12	military government of Nigeria, condemned of trumped-up charges by a biased military
13	tribunal; and
14	Whereas the Ogeni Nine had been non violently comparing for improved essial
15	Whereas, the Ogoni Nine had been non-violently campaigning for improved social conditions and a clean environment for the Ogoni People, whose Niger Delta land, air and
16	water was, and remains, severely polluted from oil extraction and whose standard of living,
17	despite the great mineral wealth their land has yielded since the early 1960s, is among the
18	lowest in the world; and

	Whereas, the international condemnation that followed the executions included the
20	suspension of Nigeria from the Commonwealth; and
21	
22	Whereas, in 1996 a United Nations mission to Nigeria found the military tribunal in
23	contravention of international and domestic law, and recommended financial relief for the
24	survivors of the Ogoni Nine, and improvements in the socio-economic conditions of the Ogoni
25	and other minorities in the Delta; and

2	Whereas, ten years later none of the UN recommendations have been implemented,
3	and the environmental and social situations have deteriorated for the Ogoni and other Delta communities; and
4	communities, and
5	Whereas, the Ogoni Nine remain convicted of a crime of which they were unjustly
6	accused and unfairly tried; and

7 8	Whereas, Ogoniland remains profoundly polluted and gas flaring continues unabated;
	and

10	Whereas, security and stability in the Niger Delta is threatened by a proliferation of
11	small arms, armed gangs and illegal oil bunkering; and
12	
13	Whereas, despite these pressures, Ogoniland remains an island of non-violence and
14	the Ogoni voted in high numbers in the 1999 elections; and
15	Whereas, stability in the Niger Delta is vital to prevent a spike in global oil costs; and
16	whereas, stability in the Niger Deita is vital to prevent a spike in global on costs, and
17	Whereas, in the interest of stability and the protection of human rights in the Delta,
18	redress should be given the Ogonis and their non-violence rewarded; now, therefore, be it

20	RESOLVED, That the Board of Supervisors of the City and County of San Francisco urges
	the Government of Nigeria to conduct a full judicial review of the trial of the Ogoni Nine, make
21	reparations to the survivors of the Ogoni Nine, increase social spending for the Ogoni and the
22	Niger Delta as a whole, ensure that all members of the security forces receive training in
23	international standards on the use of force and firearms, in particular the 1979 UN Code of
24	Conduct for Law Enforcement Officials and the 1990 UN Basic Principles on the Use of Force
25	and Firearms by Law Enforcement Officials; and be it

1	FURTHER RESOLVED, That the Board of Supervisors further urges the United Sates
2	Department of State to urgently ensure that companies operating in the Niger Delta comply
3	with the Voluntary Principles for Security and Human Rights; and be it
4	
5	FURTHER RESOLVED, That the Board of Supervisors urges international donors to
6	increase education, health, and social services aid in the Niger Delta, in full consultation with
7	local communities; and be it
8	
9	FURTHER RESOLVED, That the Board of Supervisors urges international oil companies operating in the Delta to establish a fund from oil profits, earmarked for increased education,
10	health and social services, and environmental cleanup, and administered by local
11	communities; and be it
12	
13	FURTHER RESOLVED, That the Board of Supervisors urges the Secretary General of the
14	United Nations to constitute a ten-year follow-up mission to Ogoniland and Delta areas.
