11	the YouthPOWER project for the period of October 1, 2005 to September 30, 2007; and, WHEREAS, Funding for the YouthPOWER Project was originally authorized by the Board of Supervisors under Resolution No. 844-02; and,

14	WHEREAS, The funding for this project was accepted as a continuation grant from the		
15	original funder, the US Department of Justice, Office of Juvenile Justice Programs for the		
16	period of October 1, 2003, through September 30, 2005, and,		
17	WHEREAS, The new funder for this grant is the Substance Abuse Mental Health		
	Services Administration (SAMHSA); and,		
18	WHEREAS, The SFDPH has requested from the Board of Supervisors a change in this		
19	funding from the US Department of Justice, Office of Juvenile Justice Programs (OJJP) to the		
20	Substance Abuse Mental Health Services Administration (SAMHSA); and,		
21	WHEREAS, The grant budget includes provision for indirect costs of \$31,733; and		
22	WHEREAS, Resolutions authorizing the acceptance and expenditure of grant funds		
23	may be placed automatically on consent agendas in committee, as they are usually

1	considered to be routine items, and this resolution authorizes the acceptance and expenditure		
2	of grant funding; now, therefore, be it		
3	RESOLVED, That SFDPH is hereby authorized to accept and expend retroactively a		
4	grant in the amount of \$200,000 from a new fund administrator, SAMHSA; and, be it		
5	FURTHER RESOLVED, That SFDPH is hereby authorized to accept and expend the		
6	grant funds in accordance with the requirements set forth in the original Agreement pursuant		
7	to San Francisco Administrative Code section 10-170-1; and, be it		
8	FURTHER RESOLVED, That the Director of Health is authorized to enter into the		
9	agreement on behalf of the City; and, be it		
10	FURTHER RESOLVED, That the Controller is directed to designate the position funded		
11	under this agreement as a "G" or grant-funded position which would terminate when the		
12	agreement expires.
