1	[Incorporating Street Performers Into The Street Artist Program And Designating Sound Appropriate Sales Areas For Certified Street Artists.]

3	Resolution recognizing that qualified Street Performers are eligible to participate in the
4	Street Artist Program and urging the designation of sales areas within the Program that
5	are appropriate for amplified sound.
6	
7	WHEREAS The Street Artist Ordinance adopted by the victors November 4, 1075
8	WHEREAS, The Street Artist Ordinance adopted by the voters November 4, 1975,
9	authorizes the Board of Supervisors, by resolution, to designate sales areas where any street
10	artist or craftsman previously certified may sell art or craft items; and,
11	WHEREAS, Any artist who demonstrates that the work he/she presents for certification
12	is his/her own creation, may be certified to sell that work under the Street Artists Program;
	and,
13	WHEREAS, A Street Performer who sells tapes or CDs he/she composes or arranges
14	and performs accompanied by other musicians is considered to be "selling art or craftwork of
15	his/her own creation" such that he/she is considered a Street Artist and thus qualified to
16	participate in the Street Artist Program if he/she is certified by the Arts Commission as such
17	according to City Attorney Opinion 83-61, a copy of which is on file with the Clerk of the Board
18	of Supervisors in File No. , which is hereby declared to be a part of this Resolution as if set
19	forth fully herein; and,
20	WHEREAS, The Board recognizes that the participation of Street Performers in the
21	Street Artist Program adds vitality to the unique quality of San Francisco's diverse cultural
22	activities; and,

1	WHEREAS, Currently the Street Artist Program does not certify qualified Street
2	Performers as Street Artists if the Street Performers apply and wish to sell the product of their
3	performance; and,
4	WHEREAS, There are currently 300 designated sales areas in the Street Artist
5	Program; now, therefore, be it
6	RESOLVED, That the San Francisco Board of Supervisors urges the Arts Commission
7	to immediately begin certifying qualified Street Performers as Street Artists if the Street
8	Performers apply to the Street Artist Program and wish to sell the product of their
9	performance; and, be it
10	FURTHER RESOLVED, That the Board of Supervisors urges the Arts Commission to
11	revise the Street Artist Handbook to fully incorporate the participation of Street Performers;
12	and, be it
13	FURTHER RESOLVED, That the Board of Supervisors urges the Arts Commission
14	work with the Entertainment Commission to identify, designate, and maintain certain sales
15	areas in the Street Artists Program as appropriate for amplified sound; and, be it
16	FURTHER RESOLVED, That the Board of Supervisors urges the Arts Commission and
17	the Entertainment Commission to work together to develop a cost efficient plan for
18	administering the Street Artist spaces designated as appropriate for amplified sound and for
19	issuing sound permits and to develop applicable rules for participation of Street Artists using
20	amplified sound in the Street Artist Program; and, be it
21	FURTHER RESOLVED, That the Board of Supervisors requests a joint report from the
22	Arts Commission and the Entertainment Commission within 90 days of the incorporation of
23	Street Performers into the Street Artist Program.
